## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

## RESOLUTION AMENDING RESOLUTION 11-520 PERTAINING TO PARKING VIOLATION PENALTIES REGARDING PURDON CROSSING AND EDWARDS CROSSING ALONG THE YUBA RIVER CORRIDOR

WHEREAS, pursuant to Vehicle Code § 40203.5, the Board of Supervisors shall establish the schedule of parking penalties that shall be collected as civil penalties; and

WHEREAS, the Nevada County Board of Supervisors did adopt Resolution 11-520 on November 8, 2011, which amended Resolution 95-96 adopted on March 21, 1995, which amended Resolution 94-53 adopted on February 15, 1994, whereby a Schedule of Penalties for parking and parking-related equipment and registration violations, and administrative fees was adopted; and

WHEREAS, Purdon Crossing and Edwards Crossing along the Yuba River Corridor receive numerous visitors, especially during the summer months; and

WHEREAS, these crossings comprise of narrow roads with blind spots, no shoulders and no walking paths; and

WHEREAS, unfortunately some members of the public park in "No Parking" zones at these crossings and create public safety issues, including blocking the road for emergency vehicles, and the public walking on the road from their illegally parked vehicles to access the river, in addition to the negative impact to the environment; and

WHEREAS, the Nevada County Board of Supervisors desires to provide public safety to visitors, protect the environment and provide first responders the ability to quickly and safely access both crossings; and

WHEREAS, to discourage parking in "No Parking" zones, the Nevada County Board of Supervisors establishes penalties for the Purdon Crossing and Edwards Crossing locations as identified in the attached Exhibit A, which includes the previously adopted administrative fees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that

1. The fines to be collected for the processing of all parking citations at the Purdon Crossing and Edwards Crossing along the Yuba River Corridor, as identified in the Exhibit A, Purdon Crossing and Edwards Crossing Parking Penalty Schedule, are hereby adopted.
