**<u>SUBJECT</u>**: Appointment of two Board of Supervisors representatives to the Countywide Redevelopment Oversight Board for Nevada County.

**<u>RECOMMENDATION</u>**: Adopt the proposed Resolution confirming appointments of two members to the Countywide Redevelopment Oversight Board.

## **BACKGROUND**:

In 2011, the California State legislature passed, and Governor Brown signed, Assembly Bill (AB) X1 26 dissolving redevelopment agencies throughout the State of California, and established Successor Agencies and Oversight Boards whose purpose was to wind down the affairs of a dissolved redevelopment agency. Pursuant to AB IX 26, the Grass Valley Redevelopment Dissolution Oversight Board and the Truckee Redevelopment Dissolution Oversight Board were formed in 2012 to review redevelopment projects within their jurisdictions;

As of July 1, 2018, all Redevelopment Successor Agency Oversight Boards within the County of Nevada will be dissolved pursuant to Health and Safety Code Section 34179 and there will be only one Oversight Board within the County. The Consolidated Oversight Board will continue to oversee the dissolutions of the former Grass Valley and Truckee redevelopment agencies, with the assistance of the Nevada County Auditor-Controller. The primary role of the Oversight Board is to approve the annual Recognized Obligation Payment Schedule (ROPS), which lists the various outstanding financial obligations of the Successor Agencies that are authorized and legally committed to meet for the stated time period under review.

Health and Safety Code (H&SC) Section 34179(j)(1-7) provides that the Countywide Redevelopment Oversight Board is to be comprised of seven members appointed by affected local taxing entities and the community that established the redevelopment agency, including:

- 1. One member appointed by the Board of Supervisors
- 2. One public member appointed by the Board of Supervisors
- 3. One member appointed by the City Selection Committee
- 4. One member appointed by the Special District Selection Committee

- 5. One member appointed by the Superintendent of Schools
- 6. One member appointed by the Chancellor of California Community College
- 7. One member appointed by the recognized employee organization representing the largest number of Successor Agency employees

Applications for the two Board-appointed positions were received, and District II Supervisor, Dan Miller, and District V Supervisor, Richard Anderson, recommend the appointments of Ms. Jan Arbuckle and Ms. Joan deRyks.

Please consider the appointments of Ms. Jan Arbuckle, as the Board appointed member, and Ms. Joan deRyk Jones, as the public member.
