



ORDINANCE No. 2451

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

ORDINANCE AMENDING SECTION 3.A.8 OF ARTICLE 3.A OF CHAPTER IV OF THE NEVADA COUNTY GENERAL CODE PERTAINING TO PARKING PROHIBITIONS – ALL DISTRICTS

THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA, STATE OF CALIFORNIA,
ORDAINS AS FOLLOWS:

SECTION I:

That the deletion of No Parking zones on roads no longer under the jurisdiction of the County of Nevada, the addition of existing No Parking Zones on Purdon Road and North Bloomfield-Graniteville Road and clerical corrections be approved based on the following findings A-E:

- A. That the repealed roadways are no longer County-maintained roadways;
- B. That the ordinance revision is needed to clarify that roadways annexed by the City of Grass Valley, the City of Nevada City and Truckee are no longer under the jurisdiction of the County of Nevada;
- C. That Purdon Road and North Bloomfield-Graniteville Road are County-maintained roadways;
- D. That the County has the authority to install signs within its right of way and to enact parking restrictions as needed pursuant California Vehicle Code section 22507;
- E. That the ordinance amendment is needed to protect the rights of the public on Purdon Road and North Bloomfield-Graniteville Road to access their homes and allow emergency response vehicles to use the roadways; and

SECTION II:

Section 3.A.8 of Article 3.A of Chapter IV of the Nevada County General Code is hereby replaced in its entirety as follows:

“Sec. G-IV 3.A.8 Parking Prohibitions

- A. No vehicle shall be parked at any time upon the traveled portion being approximately twenty-four feet wide, of the Soda Springs Road from the southerly end of the bridge crossing the spillway from Van Norden Lake thence southerly to the Nevada-Placer County boundary.
- B. No vehicle shall be parked at any time upon the County right-of-way used for Dog Bar Road for a distance of one thousand five hundred feet from the bridge crossing Bear River.
- C. Repealed.
- D. Repealed.

E. No vehicle shall be parked at any time upon the traversed portion of Newtown Road from State Highway 49 to 500 feet southwest on Newtown Road.

F. Repealed.

G. The Director of the Department of Public Works of the County of Nevada is hereby authorized and instructed to erect or cause to be erected, appropriate signs on various County roads and highways described in Section G-IV 3.A.7, giving notice of the prohibition of parking as declared and established by this Section.

H. Repealed.

I. No vehicle shall be parked at any time upon the County right-of-way from 1,200 feet south of the Yuba River Bridge on Pleasant Valley Road at the South Yuba State Park to 500 feet north of the Yuba River Bridge on Pleasant Valley Road at the South Yuba State Park. No vehicle shall be parked at any time upon County right-of-way in designated no parking zones on Purdon Road, both sides of Purdon Bridge, nor on North Bloomfield-Graniteville Road, both sides of the Edwards Crossing Bridge.

J. No vehicle shall be parked between the hours of 8 a.m. and 4 p.m. on school days upon the County right-of-way on Via Vista between Ridge Road and 200 feet east of its intersection with Echo Ridge Drive. (Ord. 2446, 1/23/18)"

SECTION III:

If any section, sentence, clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and adopted this ordinance and each section, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared invalid or unconstitutional.

SECTION IV:

This Ordinance shall take effect and be in full force thirty (30) days from and after introduction and adoption, and it shall become operative on the 26th day of July, 2018, and before the expiration of fifteen (15) days after its passage it shall be published once, with the names of the Supervisors voting for and against same in the Union, a newspaper of general circulation printed and published in the County of Nevada.
