

RESOLUTION No. 18-321

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION ACCEPTING FUNDING FROM THE FRIENDS OF THE NEVADA COUNTY LIBRARIES FOR \$1,450 TO BE USED FOR THE LIBRARY TO PROVIDE STIPEND PAYMENTS TO FIVE HIGH SCHOOL SUMMER INTERNS FOR USE DURING THE PERIOD JUNE 11, 2018, TO AUGUST 31, 2018, AND DIRECTING THE AUDITOR CONTROLLER TO AMEND THE FISCAL YEAR 2018/19 LIBRARY BUDGET TO REFLECT THE ADDITIONAL REVENUE AND RELATED EXPENSES (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the Nevada County Community Library has committed to supporting economic development in the County through internships which help train local unskilled workers; and

WHEREAS, the County Librarian made a request for the Friends of the Nevada County Libraries to support the Library internship program by providing funds for stipends to local high school students; and

WHEREAS, the Friends of the Nevada County Libraries agreed to provide funding in the amount of \$1,450 for stipends to the 2018 Grass Valley Library Seamless Summer Lunch interns and the Madelyn Helling Library Summer Learning Program Interns.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Board of Supervisors:

- 1. Accepts the \$1,450 from the Friends of the Nevada County Libraries for use from June 11, 2018 through August 31, 2018 and directs the Auditor-Controller to deposit the funds into the Library budget, 1165 60201 581 1000 445090.
- 2. Directs the stipend compensation shall be paid to student interns as follows:
 - a. Three Seamless Summer Lunch at the Library interns: \$250 each, totaling \$750
 - b. Two Summer Learning Program Interns: \$350 each, totaling \$700

To be eligible for the stipend payment, interns must work at least six of the 8 to 10 week periods.


3. Auditor-Controller to amend the Fiscal Year 2018/19 Library budget as follows:
