OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION TO ESTABLISH AN OUTDOOR EVENT ORDINANCE FEE SCHEDULE

WHEREAS, on August 26, 2014, The Board of Supervisors adopted Ordinance 2383 which governs Outdoor Events conducted for commercial benefit; and

WHEREAS, Article 2 of Chapter 5 of the Nevada County General Code requires the Nevada County Sheriff and the Community Development Agency to accept, review and process applications for Outdoor Events; and

WHEREAS, Article 2 of Chapter 5 of the Nevada County General Code requires the collection of an application fee; a renewal permit fee; a re-inspection fee; and an appeal fee in amounts established by resolution of the Board of Supervisors; and

WHEREAS, the County desires the fees to cover the actual costs of providing services to carry out the requirements of Article 2 of Chapter 5 of the Nevada County General Code.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Nevada County Board of Supervisors as follows:

- 1. The Outdoor Event Ordinance Fee Schedule and its provisions, Exhibit "A", is hereby adopted and made part of this resolution.
- 2. Fees adopted by this resolution shall become effective for all new Outdoor Event applications received after January 1, 2019.
