RESOLUTION APPROVING AMENDMENT NO. 1 TO THE AGREEMENT WITH CRANMER ENGINEERING, INC., FOR TESTING OF PROVIDED SAMPLES FOR WASTEWATER TREATMENT FACILITIES AND COLLECTION SYSTEMS INCREASING THE AMOUNT OF THE CONTRACT BY \$10,000 FOR A NEW MAXIMUM CONTRACT AMOUNT NOT TO EXCEED \$50,000

WHEREAS, Nevada County Sanitation District No. 1 (District) discharge permits are issued by the Regional Water Quality Control Board in which sampling is needed to meet monitoring requirements; and

WHEREAS, the District selected (Resolution SD 12-15) Cranmer Engineering, Inc., to provide sampling testing services; and

WHEREAS, Cranmer Engineering, Inc., is an ELAP (Environmental Laboratory Accreditation Program) certified wastewater quality testing lab that can provide sampling and testing services to the levels required in the Regional Water Quality Control Board permit; and


WHEREAS, the Board of Directors of Sanitation District No. 1, by Resolution SD17-010, approved a contract with Cranmer Engineering, Inc., for Fiscal Year 2017/18; and

WHEREAS, Cranmer Engineering, Inc., and the Sanitation District No. 1 wish to amend the contract by \$10,000 to allow for additional wastewater testing services in Fiscal Year 2017/18; and

WHEREAS, sufficient funds are available in Budget 4700-91005-709-1000/521520.

## **AMENDMENT TO CONTRACT WITH**

- 4. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
