## RESOLUTION ADOPTING CERTIFIED STATEMENT OF THE NEVADA COUNTY CLERK-RECORDER/REGISTRAR OF VOTERS OF THE RESULTS OF THE JUNE 05, 2018 STATEWIDE DIRECT PRIMARY ELECTION HELD IN THE COUNTY OF NEVADA.

**WHEREAS**, Elections Code Section 15372 requires that the Nevada County Clerk-Recorder/Registrar of Voters prepare a certified statement of the results of a primary election within the county and submit it to the Board of Supervisors; and

WHEREAS, the Nevada County Clerk-Recorder/Registrar of Voters did canvass the returns of the June 5, 2018 Statewide Direct Primary Election, and has certified the results of the votes cast at said election, which results are attached hereto as Exhibit "A" and incorporated herein by reference; and

**WHEREAS**, Elections Code Section 8140 provides that the Board of Supervisors shall declare elected to each office voted on at each election under its jurisdiction the person who receives a majority of all ballots cast for candidates for that office; and

WHEREAS, Elections code Section 15400 provides that the Board of Supervisors shall declare the results of each election under its jurisdiction as to each measure voted on at such election; and

**NOW, THEREFORE, BE IT RESOLVED**, Elections Code Sections 8140, and 15400 provide that the Board of Supervisors shall declare elected to each office voted on at each election under its jurisdiction the person who receives a majority of all ballots cast for candidates for that office as reflected in Exhibit A hereto, be and hereby are ratified, confirmed and approved; and
