OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NUMBER 6 TO THE AGREEMENT BETWEEN THE COUNTY OF NEVADA AND PARATRANSIT SERVICES FOR THE PROVISION OF SPECIALIZED PARATRANSIT SERVICES IN WESTERN NEVADA COUNTY

WHEREAS, on May 14, 2013, the Nevada County Board of Supervisors adopted Resolution 13-168, approving a five-year contract with Paratransit Services for provision of specialized Paratransit Services in western Nevada County that began on July 1, 2013 and will expire on June 30, 2018; and

WHEREAS, on July 22, 2014, the Nevada County Board of Supervisors adopted Resolution 14-362 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on August 11, 2015, the Nevada County Board of Supervisors adopted Resolution 15-392 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on July 26, 2016, the Nevada County Board of Supervisors adopted Resolution 16-381 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on October 11, 2016, the Nevada County Board of Supervisors adopted Resolution 16-491 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on August 15, 2017, the Nevada County Board of Supervisors adopted Resolution 17-438 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, the contract term is five years and commences on July 1, 2013, with a termination date of June 30, 2018; and

WHEREAS, the contract term may be extended for two two-year periods upon approval of the Transit Services Commission and the Board of Supervisors; and

WHEREAS, on September 20, 2017 the Transit Services Commission approved extending the Contract Agreement between Nevada County and Paratransit Services for the Provision of Specialized Paratransit Services in Western Nevada County for one two-year period between July 1, 2018 and June 30, 2020; and

WHEREAS, the contract agreement contains a provision for an annual increase of the Paratransit Services contract price that includes both a fixed vehicle service hourly rate and a fixed monthly rate on July 1st of each contract year equivalent to the increase in the CPI (California Consumer Price Index, California Department of Industrial Relations, Division of Labor Research, All Urban Consumers) for the most recent available twelve month period prior to each scheduled increase in an amount of not less than one percent, with a cap of three percent (3%) annually; and

WHEREAS, the California CPI calculation for the twelve month period of April 2017 through April 2018 reports a 3.7 percent increase; and

WHEREAS, Nevada County and Paratransit Services wish to amend the contract agreement to include an increase of the Paratransit Services' fixed vehicle service hourly rate by three percent to \$38.60 and the fixed monthly rate to \$61,765 per the applicable annual CPI effective July 1, 2018 through June 30, 2019; and

WHEREAS, there is sufficient budget available in the proposed Fiscal Year 2018-19 Transit Services budget in account 4281-91003-707-1000/521520 to fund the contract.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves the attached Amendment to extend the contract term for one two-year period beginning July 1, 2018 and ending June 30, 2020.
2. Approves the attached Amendment to increase the Paratransit Services' fixed vehicle service hourly rate to \$38.60 and the fixed monthly rate to \$61,765 through June 30, 2019 in the contract agreement.
3. Authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County the amendment between Nevada County and Paratransit Services.

AMENDMENT NO. 6

PARATRANSIT SERVICES CONTRACT

THIS AMENDMENT is executed this 17th day of July, 2018, by and between PARATRANSIT SERVICES and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Personal Services Contract between County of Nevada and Paratransit Services for Provision of Specialized Paratransit Services in western Nevada County, executed on July 1, 2013, by Resolution No. 13-168 and which agreement was subsequently amended on July 22, 2014, by Resolution Number 14-362, on August 11, 2015, by Resolution Number 15-392 and on July 26, 2016, by Resolution No. 16-381, by Resolution No. 16-491, and on August 15, 2017, by Resolution No. 17-438

NOW, THEREFORE, the parties hereto agree as follows:

1. To extend the contract term for one two-year period beginning July 1, 2018 and ending June 30, 2020.
2. To increase the Paratransit Services' fixed vehicle service hourly rate to \$38.60 and the fixed monthly rate to \$61,765 from July 1, 2018 through June 30, 2019.
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
