Friends of the Truckee Library (FOTL) is grateful to Nevada County for offering the Town the opportunity to take over library operations from the County. This would significantly improve Truckee library services by accelerating the building of the much larger multi-function library/civic building that this community wants and needs. The Town Council approved negotiations with the County with the expectation of a modern library being built in the future. This has also been FOTL's number one goal and focus since 2008.

After the Town analyzed the feasibility study, they concluded that a Town-operated library would be financially feasible for the next 10 years. The doubling of the library sales tax this past November ensures that with the use of sales tax raised In Truckee and moving forward with a new library, the Town will be better able to provide the level of library services that meets the goals of the Library Sales Tax Expenditure Plan.

FOTL has made large investments in a new library for Truckee. We have commissioned multiple professional studies that have laid the groundwork for a new library plan. These include: Needs Assessment, Funding Models, Operational Models, Space and Land Needs, and Land Surveys. We recently convened a Site Committee of local experts to review potential library sites. In March 2017, Truckee Regional Park was named top choice. With the support of the Town and Airport District the Library is now being studied as an anchor project in the civic development plan at Regional Park.

In closing, FOTL is appreciative of the Town and County working together for the benefit of our Nevada County communities. Just as in 1993, when the Truckee community voted to incorporate, recognizing that Truckee's population growth and geographic isolation would be best served by locally managed public services including roads, building, planning, and policing, now is the right time for local management of the library.
