

## RESOLUTION No. 18-402

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND THE TAHOE SAFE ALLIANCE INCREASING THE ANNUAL CONTRACT AMOUNT NOT TO EXCEED \$4,000 PER YEAR FOR THE PERIOD JULY 1, 2017 THROUGH JUNE 30, 2022 AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE CONTRACT

WHEREAS, on October 10, 2017, the Nevada County Board of Supervisors adopted Resolution 17-503, thereby entering into a Personal Services Contract with Tahoe Safe Alliance for the provision of domestic violence shelter-based services to victims of domestic violence and their children; and

WHEREAS, the Services under the Contract are funded through the collection of the Marriage License Domestic Violence Surcharge Fee pursuant to Welfare and Institutions code 18305; and


WHEREAS, funds collected through the Marriage License Domestic Violence Surcharge Fee have exceeded those originally anticipated; and

WHEREAS, the parties desire to increase the amount of Contract not to exceed a maximum of \$4,000 per year, an increase of up to \$1,000 per year, to enhance the delivery of services in accordance with the increase in marriage License Domestic Violence Surcharge Fees collected; and

WHEREAS, in all other respect the terms and conditions of the Contract shall remain unchanged.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to the Personal Services Contract, dated the 10<sup>th</sup> day of October 2017 by and between the County of Nevada and the Tahoe Safe Alliance, increasing the maximum contract amount to \$4,000 per year, be and hereby is approved and that the Chair of the Board of Supervisors is authorized to execute the amendment on behalf of the County of Nevada.

Funds will be disbursed from account 1153 50608 203 1000 532200. Administration fees to the Nevada County District Attorney shall be transferred into 0101 20103 101 1000 458010.

## **AMENDMENT #1 TO CONTRACT WITH**

Tahoe Safe Alliance (TSA)

**THIS AMENDMENT** is executed this 14th day of August 2018 by and between Tahoe Safe Alliance (TSA) and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Provide services to victims of domestic violence and their children pursuant to California Welfare and Institution Codes 18294 and 18295 executed on October 10, 2017 by Resolution No.17-503.

**WHEREAS**, the parties desire to amend their agreement to allow or provide for an increase in the maximum amount of the contract; and

**WHEREAS**, the funds received from the Marriage License Domestic Violence Surcharge Fee and the Domestic Violence Court Fees have exceeded the original projections; and

## NOW, THEREFORE, the parties hereto agree as follows:

- 1. That the Maximum Contract Price set forth at §2 is increased by \$1000 to \$4000 per year beginning with fiscal year 2017-18.
- 2. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
