**SUBJECT:** Resolution approving a contract between the County of Nevada and Rua

& Son Mechanical, Inc., for the Nevada County Roof Restoration and

Replacement Project at Various Locations for the Eric Rood

Administrative Center, the District Attorney Building, and the Animal Shelter Modular in the amount of \$533,664 plus a contingency of \$53,367 for a total contract amount of \$587,031, authorizing the Chair of the Board of Supervisors to execute the contract, and amending the Fiscal Year 2018-19 Capital Facilities Budget (4/5 affirmative vote

required).

**RECOMMENDATION:** Adopt the Resolution

**<u>FUNDING</u>**: Funds for this deferred maintenance project are available in the Capital Facilities assignment of the General fund; an additional \$500,000 was added to that assignment in the Fiscal Year 18/19 adopted budget to supplement existing funds for deferred maintenance. A budget amendment is being requested to release funding from the Capital Facilities assignment of the General Fund.

**BACKGROUND:** By previous action of the Board, Resolution 18-446 authorized the Purchasing Agent to solicit bids for the project known as the Nevada County Roof Restoration and Replacement. An Invitation to Bid was sent to builders' exchanges, local contractors were notified, and a Public Notice advertisement was posted in the local newspaper. Four (4) bids were received. The lowest responsive and responsible bid for roof restoration at the Eric Rood Administrative Center (ERAC) and the District Attorney building and the roof replacement at the Animal Shelter Modular was from Rua & Son Mechanical, Inc., of Rocklin, California, in the amount of \$444,312 and one bid alternate in the amount of \$89,352 to install metal siding on the roof parapet wall at the ERAC for a total bid amount of \$533,664. The building location and respective bid amount follows:

Eric Rood Administrative Center Roof Restoration\$474,372District Attorney Building Roof Restoration\$ 25,615Animal Shelter Modular Roof Replacement\$ 33,677

The contract will be in the bid amount of \$533,664 and a 10% contingency of \$53,367 will be added to the encumbrance for a total encumbered amount of \$587,031. A separate contract

award is being brought to this Board for the roof restoration at the Grass Valley Veterans Memorial Building. An abstract of the bid results is attached.
