
RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE TRAINING SERVICES AGREEMENT #EW-2018-24 WITH THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, UC DAVIS EXTENSION FOR TRAINING SERVICES (RESOLUTION 18-266)

WHEREAS, per Resolution 18-266, the County has contracted with the University of California, Davis University Extension for approximately the past twenty years for the provision of a quality Eligibility Services Training Program; and

WHEREAS, the parties desire to amend the Agreement Exhibit "A" to reflect an increase in total number of training units from 25 units to 35 units thereby increasing the total cost of training.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to Agreement #EW-2018-24 by and between the County and The Regents of the University of California, Davis University Extension pursuant to increasing the number of training units from 25 to 35 units of training services provided during Fiscal Year 2018/19, and increase the maximum total cost of training from \$106,250 to \$148,750 (an increase of \$42,500), with a University in-kind contribution increasing from \$10,625 to \$14,875 (an increase of \$4,250), and \$95,625 to \$133,875 (an increase of \$38,250) being the County's share of cost, be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Agreement on behalf of the County of Nevada.
