RESOLUTION APPROVING AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND PRO-LINE CLEANING SERVICES, INC., FOR JANITORIAL SERVICES AT VARIOUS COUNTY FACILITIES, INCREASING THE CONTRACT AMOUNT BY \$65,000 FOR A MAXIMUM CONTRACT PRICE OF \$130,000, EXTENDING THE TERM OF THE CONTRACT TO JUNE 30, 2019, AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AMENDMENT


WHEREAS, janitorial services are essential to the health and safety of County facilities and the Nevada County Purchasing Agent and Auditor/Controller have determined the most efficient way to procure and process payments for janitorial services on behalf of all departments is through a single master contract; and

WHEREAS, Resolution 18-319 authorized a contract with Pro-Line Cleaning Services, Inc., to provide services for the period July 1, 2018 through December 31, 2018 to allow the Purchasing Agent time to issue a Request for Proposals for a longer-term contract; and

WHEREAS, the Purchasing Agent requires more time to consult with departments concerning their current and future janitorial needs before issuing a Request for Proposals.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors hereby directs that:

- 1. The Board approves and the Board Chair is authorized to execute Amendment No. 1 to the Personal Services Contract by and between the County of Nevada and Pro-Line Cleaning Services, Inc., for janitorial services at various County facilities.
- 2. The Maximum Contract Price of \$65,000 is increased by \$65,000 to \$130,000.
- 3. The Contract Termination Date is extended to June 30, 2019.
- 4. In all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
