RESOLUTION ACCEPTING A GRANT FROM THE CALIFORNIA PUBLIC UTILITIES COMMISSION FOR \$85,781.20 FROM THE CALIFORNIA ADVANCED SERVICES FUND ADOPTION PROGRAM FOR THE NEVADA COUNTY LIBRARY PUBLIC ACCESS UPGRADE PROJECT, AND TO DIRECT THE AUDITOR CONTROLLER TO AMEND THE FISCAL YEAR 2018/19 LIBRARY BUDGET TO REFLECT THE ADDITIONAL REVENUE AND RELATED EXPENSES (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the California Public Utilities Commission requested proposals for grant funding to increase publicly available or after-school broadband access and digital inclusion; and

WHEREAS, the County of Nevada Librarian presented a proposal to fund the purchase of public computers, public printer/scanners, payment boxes for public printing and related technical support; and

WHEREAS, the grant was approved by the California Public Utilities Commission awarding \$20,074.70 for the Madelyn Helling Library; \$23,151.94 for the Grass Valley Library; \$19,402.62 for the Truckee Library; and \$23,151.94 for the Penn Valley Library.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Board of Supervisors:

- 1. Accepts the California Public Utilities Commission grant for \$85,781.20 for use from December 31, 2018 through December 31, 2019, authorizes the Chair to sign the consent form and acceptance letters, and directs the Auditor-Controller to deposit the funds into the Library budget, 1165 60201 581 1000 445090.
- 2. Directs the Auditor-Controller to amend the Fiscal Year 2018/19 Library budget as follows:

Nevada County Library shall make these records available to the Commission upon request and agree that these records are subject to audit and review by the Commission at any time within three years after Grantee has incurred the expense being audited. **Payment**

Grantees may submit up to three payment requests throughout the project period. Payment requests will accompany the 3 reports required above. Payment will be based upon receipt and approval of invoices and other supporting documents showing that expenditures incurred for the project are in accordance with their approved application and budget.

The Commission has the right to conduct any necessary audit, verification, and discovery during project implementation to ensure that CASF funds are spent in accordance with the terms of approval the Commission grants. Please refer to the Administrative Manual posted on the CASF page on the CPUC 's website for the payment request templates.

Execution and Performance

Grantee must begin the project within six months after the CPUC grant's approval (after the ramp –up time if applicable) and must complete the project within 24-months. The Commission may withhold or terminate grant payments if the Grantee does not comply with any of the requirements set forth in its application and with the CASF rules. If the Grantee fails to complete the project in accordance with the terms of approval the Commission's grant, the grantee must reimburse some or all the CASF funds that it has received.
