WHEREAS, the County of Nevada entered into a Standard Public Works Contract PESM3684 with Buskirk Construction Inc, dba Buskirk Building Solutions (10556 Combie Road No. 6481, Auburn, CA, 95602), totaling \$19,250 including a 10% contingency; and


WHEREAS, said Contract was for the Eric Rood Administrative Center Assessor Office Remodel Project in accordance with the plans and specifications; and


