Resolution approving execution of Amendment #2 to the renewal contract with Community **SUBJECT:** Recovery Resources (CoRR) to provide Perinatal and Non-Perinatal Outpatient Drug Free Treatment (ODF) and Intensive Outpatient Treatment (IOT) Services for substance using pregnant and/or parenting women, men and adolescents; Comprehensive Residential Treatment Program Services for the recovery of alcohol/drug dependency; and Substance Abuse Prevention and Treatment Services, to residents of Nevada County, to incorporate grant funding received from Community Based Transitional Housing (CBTH) in the amount of \$186,556, thereby amending in the maximum price to \$1,930,118 (an increase of \$186,556) for fiscal year 2018/19, and amending and replacing Exhibits "A" and "B" to reflect the additional services and increase in the maximum contract price.

RECOMMENDATION: Approve the attached Resolution.

FUNDING: Contract services are supported by: Health Resources and Services Administration (HRSA) for the Rural Health Opportunity Program (RHOP); State Department of Finance Community Based Transitional Housing (CBTH) Grant funds; Federal SAPT (Substance Abuse Prevention and Treatment) Block Grant funds; 2011 Realignment; Court generated Statham funds; Drug Medi-Cal Federal reimbursement; Supportive and Therapeutic Options Program (STOP) funds and funds made available from the Probation Department. The amendment is within the department's FY 18/19 budget, there are no County general fund dollars required in the contract.

BACKGROUND: On August 14, 2018, pursuant to Resolution No. 18-398, the Board approved the renewal contract between the County and Community Recovery Resources for the provision of Perinatal and Non-Perinatal drug treatment Services within the modalities of Outpatient Drug Free (ODF) Treatment and Intensive Outpatient (IOT) Treatment, Residential Treatment, Residential Crisis, Transitional and Withdrawal Management Programs, Prevention and Outpatient Treatment Programs, and Ancillary Services.

This contract was subsequently amended per Amendment #1 on November 13, 2018, which incorporated additional funding in the amount of \$61,350.74, received from a Community Based Transitional Housing (CBTH) grant through the State Department of Finance. The additional funding allowed for expanded services through this contract, including the ability to admit eligible individuals to the Lovett Recovery Center at Bost House on weekends, vehicle purchase, and safety enhancements on site.

This Amendment #2 incorporates additional funding received from the Health Resources and Services Administration (HRSA) for the Rural Health Opportunity Program in the amount of \$186,556. The additional funding will allow for expanded services, including intensive case management services to the identified target population including navigation, linkage to needed community services, transitional housing, and post treatment follow-up, as reflected in the amended Exhibit "A" Schedule of Services.
