1. SUMMARY

The Nevada County Purchasing Division, on behalf of the Department of Public Works, hereinafter collectively referred to as "County," is requesting Statements of Qualification (SOQ) from all qualified firms to provide preliminary engineering, right of way acquisition, environmental, and design services.

The term "offeror" as used herein shall refer to providers submitting a SOQ in response to this Request for Qualifications (RFQ). The term "Contractor" or "Provider" is also used to describe the successful offeror(s) in the context of providing services under a contract resulting from this RFQ.

Each SOQ received in response to this RFQ will be evaluated on the criteria described herein. All responses must be sealed, clearly marked "SOQ – Preliminary Engineering and Design for the Rough and Ready Highway/Ridge Road and Rough and Ready Highway/Adam Avenue Intersection Improvement Project" and must include all elements described in the **SOQ CONTENT AND FORMAT REQUIREMENTS** section of this RFQ. One (1) original and four (4) copies of your proposal as well an electronic version must be submitted as directed on page 1 before the date and time listed in the **CONTRACT AWARD SCHEDULE** section of this RFQ. The County will not be responsible for a SOQ delivered to a person or location other than that specified herein, and reliance on the postal service will not excuse a late submission.

Questions or requests for clarification of this Request for Qualifications must be submitted in writing no later than the date and time listed in the CONTRACT AWARD SCHEDULE section of this RFQ. Responses to questions will be published in an addendum after the question submittal deadline has passed. The County reserves the right to decline to respond to any questions.

3. GENERAL CONDITIONS

- 3.1. Prime Responsibility: The selected Contractor(s) will be required to assume full responsibility for all services and activities offered in its/their SOQ(s), whether or not provided directly. Further, the County will consider the selected Contractor(s) to be the sole point of contact with regard to contractual matters, including payment of any and all charges resulting from the contract.
- 3.2. Assurance: Any contract awarded under this RFQ must be carried out in full compliance with Title VI and VII of the Civil Rights Act of 1964 as amended, and Section 504 of the Rehabilitation Act of 1973 as amended. The Provider must guarantee that services provided will be performed in compliance with all applicable county, state and federal laws and regulations pertinent to this project. Prior to executing an agreement the Provider will be required to provide evidence substantiating the necessary skill to perform the duties through the submission of references.
- 3.3. The Health Insurance Portability and Accountability Act of 1996 (Public Law 104-199 (HIPAA): Any contract awarded under this RFQ must comply with the requirement of 42 U.S.C. §§ 1171 et seq., Health Insurance Portability and Accountability Act of 1996 (HIPAA) and its subsequent amendments, related to Protected Health Information (PHI), in performing any task or activity related to this Agreement.
- 3.4. Independent Contractor: In performance of the work, duties and obligations assumed by the offeror, it is mutually understood and agreed that the offeror, including any and all of the offeror's officers, agents and employees, will at all times be acting and performing in an independent capacity and not as an officer, agent, servant, employee, joint venture, partner or associate of the County.
- 3.5. Publicity Clause: Awarded firm(s) shall obtain prior written approval from the County for use of information relating to the County or any resulting Agreement in advertisements, brochures, promotional materials or media, press releases or other informational avenues.
- 3.6. Non-Collusion: Firms submitting proposals shall warrant that their offer is made without any previous understanding, agreement or connection with any person, firm or corporation submitting a separate proposal for the same project and is in all respects fair, without outside control, collusion, fraud or otherwise illegal action. This condition shall not apply to proposals which are submitted by firms who have partnered with others to submit a cooperative proposal that clearly identifies a primary contractor and the associated sub-contractors.
- 3.7. Protests and Appeals: Any actual or prospective proposer, offeror, or contractor who is aggrieved in connection with the solicitation or award of a contract may appeal to the Director of Information & General Services. The protest shall be submitted in writing to the Director of Information & General Services within seven (7) business days after such aggrieved person or company knows, or should have known, of the facts giving rise thereto.
- 3.8. Nevada County prohibits discrimination in employment or in the provision of services because of race, color, religion, religious creed, sex, age, marital status, ancestry, national origin, political affiliation, physical disability or medical condition. This clause does not require the hiring of unqualified persons.
- 3.9. Costs will not be considered in evaluating a SOQ. Any pricing information, if provided, must be enclosed in a sealed envelope and labeled "Pricing Information". Pricing information will not be opened until after the County has selected the most qualified offeror based on the criteria published

herein. The County reserves the right to negotiate specific terms, conditions, compensation, and provisions on any contracts that may arise from this solicitation. Should the County fail to reach a contract with the selected offeror; the County will cease negotiations and begin negotiations with the next highest rated offeror from the SOQ evaluation.

- 3.10. Nevada County reserves the right to:
 - Reguest clarification of any submitted information;
 - Set aside a SOQ for any irregularity including but not limited to missing information;
 - Not enter into any agreement;
 - Not to select any applicant;
 - Amend or cancel this process at any time;
 - Interview applicants prior to award and request additional information during the interview;
 - Negotiate a multi-year contract or a contract with an option to extend the duration;
 - Award more than one contract if it is in the best interest of the County; and/or
 - Issue a similar RFQ in the future.
- 3.11. Qualified offerors must be prepared to enter into the County's standard Contract, a sample of which is attached as Attachment A to this RFQ. Please review the details of Attachment A carefully. By reference, it incorporates many standards, terms and conditions required as part of this RFQ. The County intends to award contracts substantially in the form of the sample agreement to the selected offeror(s). Portions of this RFQ and the offeror's SOQ may be made part of any resultant Contract and incorporated in the Contract. By submitting a SOQ in response to this RFQ, the Offeror certifies that no exceptions are taken to the form of the sample contract presented in Attachment A or to the provisions thereof, unless such exceptions are fully disclosed in Offeror's SOQ. Offerors that take exception to the County's standard terms and conditions do so at the risk that their SOQ may be declared to be nonresponsive and not considered for contract award.
- 3.12. Prior to commencement of services, the Contractor must provide evidence of the following insurance coverages: Worker's Compensation, Commercial General Liability (naming the County of Nevada as additional insured), Comprehensive Business or Commercial Automobile Liability for Owned Automobiles and Non-owned/Hired Automobiles, Errors and Omissions insurance; and Professional Liability or Malpractice Insurance. The Contractor will be required to maintain the required coverages, at its sole cost and expense, throughout the entire term and any subsequent renewal terms of the contract.
- 3.13. Pursuant to the County's Green Procurement and Sustainable Practices Policy, each offeror is requested to use recycled products and sustainable practices whenever possible in preparing its SOQ, including using post-consumer recycled content paper and packaging products, and copying on both sides of the paper.
- 3.14. The County of Nevada encourages its contractors and subcontractors to use the US. Citizenship and Immigration Services E-Verify system to verify that employees are eligible to work in the United States. Information about the E-Verify system is available at www.dhs.gov/e-verify.
- 3.15. Proprietary Information: Trade secrets or similar proprietary data that the prospective contractor does not wish disclosed to other than personnel involved in the SOQ evaluation effort or post-award contract administration will be kept confidential to the extent permitted by law as follows. Each page alleged to contain proprietary information shall be identified by the prospective contractor in boldface text at the top and bottom as "PROPRIETARY." Any section of the SOQ that is requested to remain confidential shall also be so marked in boldface text on the title page of that section. Despite what is labeled as confidential, proprietary, or trade secret, the determination as to whether or not certain material is confidential, proprietary or trade secret shall be determined in accordance with applicable law. If a prospective contractor designates any information in its SOQ as proprietary pursuant to this provision, the prospective contractor must also submit one copy of the proposal from which the proprietary information has been excised. The proprietary material shall be excised in such a way as to allow the public to determine the general nature of the material removed and to retain as much of the content of the SOQ as possible.

4. BACKGROUND

The County of Nevada has been awarded Congestion Mitigation and Air Quality (CMAQ) Improvement Program funding, a Federal funding program under the Fixing America's Transportation Act (FAST Act) for the Rough and Ready Highway/Ridge Road and Rough and Ready Highway/Adam Avenue Intersection Improvement Project. The project is fully funded by the program and the program's toll credits.


The project is located in the unincorporated area of Grass Valley, Nevada County, at the intersections of Rough and Ready Highway/Ridge Road and Rough and Ready Highway/Adam Avenue. The project consists of realigning these three-legged intersections to one four-legged intersection. The improvements would also convert the side-street stop controls to a single intersection with signal or roundabout control. In addition to citizen input solicited during the public outreach process, a preliminary engineering analysis evaluating right-of-way, delay reduction, cost-benefit, anticipated environmental impacts, and traffic safety will determine the final selected project. Design considerations should include pedestrian and bicycle movements as well as consideration of access, parking, and traffic circulation for the newly constructed Yuba River Charter School at the Rough and Ready Highway/Adam Avenue intersection.

The purpose of the project is to reduce existing and future delays that result in excessive pollutant emissions from idling vehicles. Rough and Ready Highway is classified as a Minor Arterial and serves approximately 6,500 vehicles per day. The intersection of Rough and Ready Highway/Ridge Road currently has an average delay of 37.6 seconds per vehicle in the AM peak hour [Level of Service (LOS) E] and 116.1 seconds in the School PM peak hour (LOS F). By 2030, if no improvements are made, the delay is expected to be 112 seconds in the AM peak hour (LOS F) and 145.9 seconds in the School PM peak hour (LOS F). New delays are also in effect from the recently constructed K-8 Yuba River Charter School at the intersection of Rough and Ready Highway/Adam Avenue.

Ancillary project benefits will include increased safety for drivers, pedestrians, and bicyclists with more predictable traffic movements, better sight distance, and traffic calming in the area.

5. DESCRIPTION OF SERVICES REQUIRED

The selected consultant shall evaluate various roundabout and signalized intersection options for the realignment of the two subject intersections, prepare all necessary environmental studies for the project, obtain all the necessary environmental and regulatory permits, prepare project plans, specifications, and cost estimates, and prepare any needed right-of-way/easement documents to construct the project. It is anticipated that this project will require an Initial Study for CEQA clearance. NEPA clearance will be required for the project but will be done by Caltrans.

Time is of the essence to complete this project. Consultants are encouraged to consider time saving options for design, permitting and construction.

5.1. The Consultant will be expected to perform the following:

Project management: Provide day-to-day project management for all aspects of the project. Act as the lead for project development and coordination, and be responsible for development of schedules and all internal coordination as applicable.

Progress reports: Provide the County with detailed monthly progress reports and facilitate monthly project development team meetings if needed.

Preliminary alternatives analysis: Review the existing conditions and develop a preferred alternative for intersection realignment and control. Respond to feedback from the County and other interested parties (e.g., public, residents, agencies) to select a final project design.

Design and construction documents: Design and prepare plans, specifications, and construction cost estimates (PS&E) for the final preferred intersection realignment and control design. It is anticipated that the consultant will prepare an entire specification package, not just the project special provisions.

Value engineering and constructability review: Provide for county reviews of design plans performed at 30, 60, 90 and 100-percent progress, as well as county reviews of all draft reports.

Geotechnical services: As necessary, perform geotechnical exploration, studies and reporting suitable for roadway design and environmental documentation support (as needed). The consultant shall review existing geotechnical study information to determine the need to provide supplemental or new studies.

Engineering, topographic and right of way surveying: Provide professional surveying services as needed to support preliminary engineering.

Bid and construction support: Provide support during the project bidding and construction phases.

Environmental reporting, documentation and permits: Consultant will be responsible for all CEQA studies, documentation, and permits. As mentioned previously the County anticipates that an Initial Study will be will required for environmental clearance.

Regulatory agency permitting requirements: Consultant will be responsible for coordinating with various regional, state, and federal agencies (e.g., Regional Water Quality Control Board, California Department of Fish and Wildlife, US Army Corps of Engineers, etc.) to acquire all necessary permits and approvals.

Constructability review support: The Consultant shall coordinate with the County's construction management and inspection consultants during their independent review of the project (under contract separately with the County; see 5.2 below).

Property acquisition and utility relocation coordination: The County currently has 80 feet of right-of-way on Rough and Ready Highway and Ridge Road, and 60 feet on Adam Avenue. The County expects minimal permanent right of way acquisitions will be needed for the project. However, the Consultant shall be responsible for all property and easement acquisitions and utility relocation coordination efforts. The consultant shall review existing right of way information to determine the need for additional property acquisition and utility relocation as needed.

Time is of the essence: The County is delivering the project in an expeditious manner. The Consultant shall prioritize the timely delivery of project deliverables with documentation and relevant experience provided by the Consultant to support the proposed project schedule.

5.2. County shall perform the following unless otherwise noted:

Project management and oversight: Provide project oversight, including review of final documents, reports and studies (as needed). All Board of Supervisors staff reports and resolutions pertaining to the project will be prepared by the County. Additionally, the County will review and approve project schedules and budgets.

Public outreach and meetings: The County will serve as project lead for all public outreach activities and public meetings, and will coordinate the provision of public input to the Consultant. Consultant may be requested for support services as needed.

Constructability review: The County will utilize one of its on-call construction management and inspection services consultants to provide an independent constructability review.

6. DISADVANTAGED BUSINESS ENTERPRISE (DBE) REQUIREMENTS

The COUNTY has established a DBE Contract goal of 18% for this project.

The submittal of all DBE Program forms with the proposal is essential to the overall success of this project, is required by the Federal laws providing funding, and can be a condition of award. It is important these forms and documents are accurately and completely filled out with response to all questions. When completing the required information it is helpful to have the forms typed or clearly printed.

The following forms have been included in this proposal (see **Attachment E**):

- Exhibit 10-I Notice to proposers DBE Information
- Exhibit 10-O1 Consultant Proposal DBE Commitment

Consultants must give consideration to DBE firms as specified in 23 CFR 172.5(b), 49 CFR, Part 26, and as stated in Exhibit 10-I, Notice to Proposers DBE Information. The consultant must meet the DBE goal by using DBEs as subconsultants or document a good faith effort to meet the goal.

7. PREVAILING WAGE REQUIREMENTS

The services described herein are for publicly funded projects, considered "public works" as defined by California Labor Code Section 1720 et seq. Any firm awarded a contract as the result of this RFQ shall be responsible for compliance with all applicable prevailing wage laws, as well as any and all applicable state or federal wage laws, for services performed under any resulting contract.

8. ASSURANCE OF DESIGNATED STAFF

Proposers shall assure that the designated staff, including subcontractors, is used for the work described in this RFQ. Departure of reassignment of, or substitutions for, any member of the designated team or subcontractor(s) shall not be made without the prior written approval of the County.

9. SOQ CONTENT AND FORMAT REQUIREMENTS

Each response to this RFQ shall include the information described in this section. Provide the information in the specified order. Failure to include all of the elements specified may be cause for rejection. Additional information may be provided, but should be succinct and relevant to the goals of this RFQ. Excessive information will not be considered favorably.

All copies of the proposal should be bound or contained in loose leaf binders. Document pages shall be 8-1/2 inches by 11 inches in size or folded to such a size. Use section dividers, tabbed in accordance with this Section as specified below:

Cover Sheet and Introductory Letter (Attachment B)

Cover Sheet: The cover sheet must be signed by an owner, corporate officer, or agent authorized by the Contractor.

Introductory Letter: Identify the office location or locations where the Consultant and any sub consultants will accomplish the work. This letter should contain an expression of the Consultant's interest in the work, a brief summary statement regarding the qualifications of the Consultant to do the work, and a brief summary of any information about the project team or the Consultant that may be useful or informative to the County.

9.1. TAB A: Experience

- Provide an overview of the types of work and history of your organization relevant to this project. Include a high-level account of your qualifications as they relate to this SOQ.
- Provide examples and references that substantiate your (organization's) experience in providing the types of service requested in this SOQ. This needs to be detailed and verifiable. Discuss the qualifications and experience of the firm, project manager, project team and subconsultants on similar projects.
- Describe any current, pending or past litigation (within the last 10 years) that the organization has been, is, or is expected to be a party to.

9.2. TAB B: Project Approach

- Itemize the complete list of services to be provided
 - Note instances where services exceed the scope or detail offered in this SOQ

- Address instances where possible cost efficiencies may be gained, quality may be improved or County may otherwise benefit from adopting your SOQ over the generally listed terms of this RFQ

- Describe your approach for ensuring that communication with County staff is adequate and timely, and that submittals are complete and on time.

- Describe any innovative techniques that you may utilize for design and constructability.

9.3. TAB C: Project Management and Staffing

- Provide names and qualifications of key employees who will be assigned to this work.
- Provide a staffing plan for meeting the requirements.
- Provide other relevant information that can aid County in its selection process.
- Provide a listing of current work commitments to other projects or activities in sufficient detail to indicate that the organization and all of the individuals assigned to the proposed project will be able to meet the needs of the projects based on the anticipated schedules described in Section 4 of this RFQ.

9.4. TAB D: Proposed Delivery Schedule

Provide a proposed delivery schedule for this project that illustrates your understanding of how the project components would be phased, overlap, and are dependent on one another. Approximate total number of hours should also be included.

9.5. TAB E: Applicable References

This section should describe work that is similar in scope and complexity to the project identified in this RFQ and that the consulting team has undertaken in the last five years. A discussion of the challenges faced and solutions developed by the team is highly recommended. Provide a summary table showing the following information:

Name of project, construction cost, and date services were provided

- Names of project manager and key team personnel
- Scope of the team's assignment on the project
- · Name, address and current phone number of the Agency Project Manager

NOTE: A minimum of three references are required for the prime Consultant and any subconsultants on the project team. Each may be contacted by County staff. References with incorrect contact information will not count toward the required minimum.

9.6. TAB F: Exceptions – Describe any and all proposed exceptions, alterations or amendments to the Scope of Work or other requirements of this RFQ, including the Sample Personal Services Agreement (Attachment A). The nature and scope of your proposed exceptions may affect the evaluation of your submittal and the County's determination of whether it is possible to successfully negotiate a contract with your firm/individual.

9.7 Cost Information

Please provide your Cost Proposal in a separate sealed envelope labeled "Cost Proposal." This information will not be considered in the evaluation of the Statements of Qualifications. **DO NOT INCLUDE PRICING INFORMATION WITH YOUR EMAILED SOQ.**

When preparing your Cost Proposal, use the form provided in **Attachment D** and provide a total cost proposal for all services to be delivered, and a breakdown of costs delineated by task as described in your project plan. Include a schedule of hourly rates for all proposed staff and the amount of time each person will be devoted to this project. Include a budget for inspection overtime based upon your firms experience and the number of construction working days. Define any reimbursable expenses requested to be paid by the County. The cost proposal must be in a specified rate of compensation format in accordance with Chapter 10 of the Caltrans Local Assistance Procedures Manual; indicate whether or not your firm's overhead rate has been audited by Caltrans Division of Audits and Investigations or other equivalent method.

10. SELECTION PROCEDURES

After an initial review and evaluation of each of the SOQs, the offerors submitting the most highly rated SOQs may be invited for interviews prior to final selection, to further elaborate on their SOQs. The County reserves the right to award a contract without holding interviews, in the event the written SOQs provide a clear preference on the basis of the criteria described.

When the most qualified offeror has been determined, the sealed pricing information for only that offerer will be unsealed and the County will enter into negotiations with that offeror. In the event that the County is unable to successfully negotiate a contract with that offeror, then the pricing information for the next most qualified offeror will be unsealed, and so on until a contract is successfully negotiated.

The Contractor(s) selected for this project will be required to accept the County's standard contract and to comply with insurance standards as deemed acceptable to the County's Risk Manager. No agreement with the County of Nevada is in effect until both parties have signed a contract.

Time for Performance

3. Contract Term:

10. Miscellaneous Insurance Provisions: (County Resolution No. 90675)

All policies of insurance required by this Contract shall remain in full force and effect throughout the life of this Contract and shall be payable on a "per occurrence" basis unless County specifically consents to "claims made" coverage. If the County does consent to "claims made" coverage and if Contractor changes insurance carriers during the term of this Contract or any extensions hereof, then Contractor shall carry prior acts coverage.

Insurance afforded by the additional insured endorsement shall apply as primary insurance, and other insurance maintained by County, its officers, agents and/or employees, shall be excess only and not contributing with insurance required or provided under this agreement.

At all times, Contractor shall keep and maintain in full force and effect throughout the duration of this Contract, policies of insurance required by this Contract which policies shall be issued by companies with a Best's Rating of B+ or higher (B+, B++, A-, A, A+ or A++), or a Best's Financial Performance Rating (FPR) of 6 or higher (6, 7, 8 or 9) according to the current Best's Key Rating Guide, or shall be issued by companies approved by the County Risk Manager. In the event the Best's Rating or Best's FPR shall fall below the rating required by this paragraph, Contractor shall be required to forthwith secure alternate policies which comply with the rating required by this paragraph, or be in material breach of this Contract.

Failure to provide and maintain the insurance policies (including Best's ratings), endorsements, or certificates of insurance required by this Contract shall constitute a material breach of this agreement (herein "Material Breach"); and, in addition to any other remedy available at law or otherwise, shall serve as a basis upon which County may elect to suspend payments hereunder, or terminate this Contract, or both. (See §Error! Reference source not found., ¶2, below, as these provisions additionally apply to subcontractors.)

11. Indemnity:

Nothing herein shall be construed as a limitation of Contractor's liability, and Contractor shall indemnify, defend and hold harmless the County and its officers, officials, employees, agents and volunteers from any and all liabilities, claims, demands, damages, losses and expenses (including, without limitation, defense costs and attorney fees of litigation) which result from the negligent act, willful misconduct, or error or omission of Contractor, except such loss or damage which was caused by the sole negligence or willful misconduct of County or its officers, officials, employees, agents and volunteers.

12. Contractor as Independent:

Contractor shall not substitute nor replace any personnel for those specifically named herein or in its proposal without the prior written consent of County.

Contractor shall cause and require each transferee, subcontractor and assignee to comply with the insurance provisions set forth herein at §§Error! Reference source not found., Error! 14. Licensing and Permits:

Contractor warrants (i) Contractor is qualified and competent to provide all Services under this contract; (ii) Contractor and all employees of Contractor hold all necessary and appropriate licenses therefor, including those licenses set forth at §Error! Reference source not found., page one (1) hereof; and, (iii) Contractor shall obtain, and remain in compliance with, all permits necessary and appropriate to provide said Services. Contractor shall cause said licenses and permits to be maintained throughout the life of this Contract. Failure to do so shall constitute a Material Breach of this agreement, and, in addition to any other remedy available at law or otherwise, shall serve as a basis upon which County may elect to suspend payments hereunder, or terminate this Contract, or both.

Public Contracts

15. Prevailing Wage and Apprentices:

To the extent made applicable by law, performance of this Contract shall be in conformity with the provisions of California Labor Code, Division 2, Part 7, Chapter 1, commencing with Section 1720 relating to prevailing wages which must be paid to workers employed on a public work as defined in Labor Code §§1720, et seq.; and shall be in conformity with Title 8 of the California Code of Regulations §§200 et seq., relating to apprenticeship. Where applicable:

- (i) Contractor shall comply with the provisions thereof at the commencement of Services to be provided herein, and thereafter during the term of this Contract. A breach of the requirements of this section shall be deemed a material breach of this contract. Applicable prevailing wage determinations are available on the California Department of Industrial Relations website at http://www.dir.ca.gov/OPRL/PWD.
- (ii) Contractor and all subcontractors must comply with the requirements of Labor Code Section 1771.1(a) pertaining to registration of contractors pursuant to Section 1725.5. Registration and all related requirements of those Sections must be maintained throughout the performance of the Contract.
- (iii) Contracts to which these prevailing wage requirements apply are subject to compliance monitoring and enforcement by the Department of Industrial Relations. Each contractor and subcontractor must furnish certified payroll records to the Labor Commissioner at least monthly.
- (iv) The County is required to provide notice to the Department of Industrial Relations of any public work contract subject to prevailing wages within five (5) days of award.

16. Accessibility (County Resolution No. 00190):

It is the policy of the County of Nevada that all County services, programs, meetings, activities and facilities shall be accessible to all persons, and shall be in compliance with the provisions of the Americans With Disabilities Act and Title 24, California Code of Regulations. To the extent this Contract shall call for Contractor to provide County contracted services directly to the public, Contractor shall certify that said direct Services are and shall be accessible to all persons.

17. Nondiscriminatory Employment:

In providing Services hereunder, Contractor shall not discriminate against any employee or applicant for employment because of race, color, religion, age, sex, national origin, political affiliation, ancestry, marital status or disability. This policy does not require the employment of unqualified persons.

18. Prior Nevada County Employment (County Resolution No. 03-353):

Effective July 22, 2003, it is the policy of the County of Nevada that former members of the Board of Supervisors, a former CEO, or a former Purchasing Agent, for a period of twelve (12) months following the last day of employment, shall not enter into any relationship wherein that former employee or former Board member receives direct remuneration from a legal entity that, during the last twelve (12) months of said employment or Board member's service, entered into a contract with, or received a grant from the County of Nevada. Provided however, that this prohibition shall not apply to any employee that did not personally approve a contract with or grant to said legal entity during the last twelve (12) months of said employment, and shall not apply when the Board of Supervisors did not approve a contact with or grant to said legal entity during the last twelve (12) months of said Board member's service.

A violation of this policy shall subject Contractor to all of the remedies enumerated in said resolution and as otherwise provided in law, which remedies shall include but not be limited to injunctive relief, cancellation and voiding of this contract by County, a return of grant money, a cause of action for breach of contract, and entitlement to costs and reasonable attorney fees in any action based upon a breach of contract under this provision.

19. Cost Disclosure:

In accordance with Government Code Section 7550, should a written report be prepared under or required by the provisions of this Contract, Contractor agrees to state in a separate section of said report the numbers and dollar amounts of all contracts and subcontracts relating to the preparation of said report

Default and Termination

20. Termination:

A Material Breach of this Contract pursuant to the terms hereof or otherwise, in addition to any other remedy available at law or otherwise, shall serve as a basis upon which County may elect to immediately suspend payments hereunder, or terminate this contract, or both, **without notice**.

If Contractor fails to timely provide in any manner the services materials and products required under this Contract, or otherwise fails to promptly comply with the terms of this Contract, or violates any ordinance, regulation or other law which applies to its performance herein, County may terminate this Contract by giving **five (5) days written notice** to Contractor.

Either party may terminate this Contract for any reason, or without cause, by giving **thirty (30)** calendar days written notice to the other, which notice shall be sent by registered mail in conformity with the notice provisions, below. In the event of termination not the fault of the Contractor, the Contractor shall be paid for services performed to the date of termination in accordance with the terms of this Contract. Contractor shall be excused for failure to perform services herein if such performance is prevented by acts of God, strikes, labor disputes or other forces over which the Contractor has no control.

County, upon giving **sixty (60) calendar days written notice** to Contractor, shall have the right to terminate its obligations under this Contract at the end of any fiscal year if the County or the State of California, as the case may be, does not appropriate funds sufficient to discharge County's obligations coming due under this contract.

Miscellaneous

21. Books of Record and Audit Provision:

Contractor shall maintain complete records relating to this Contract for a period of five (5) years from the completion of Services hereunder. Said records shall include but not be limited to bids and all supporting documents, original entry books, canceled checks, receipts, invoices, payroll records including subsistence, travel and field expenses, together with a general ledger itemizing all debits and credits

Contractor shall permit County to audit said records as well as such related records of any business entity controlled by Contractor. Said audit may be conducted on Contractor's premises or at a location designated by County, upon fifteen (15) days notice. Contractor shall promptly refund any moneys erroneously charged and shall

be liable for the costs of audit if the audit establishes an over-charged of five percent (5%) or more of the Maximum Contract Price.

22. Intellectual Property:

All original photographs, diagrams, plans, documents, information, reports, computer code and all recordable media together with all copyright interests thereto (herein "Intellectual Property"), which concern or relate to this Contract and which have been prepared by, for or submitted to Contractor, shall be the property of County, and upon fifteen (15) days demand therefor, shall be promptly delivered to County without exception. Provided however, for personal purposes only and not for commercial, economic or any other purpose, Contractor may retain a copy of Contractor's work product hereunder.

23. Entire Agreement:

This Contract represents the entire agreement of the parties, and no representations have been made or relied upon except as set forth herein. This Contract may be amended or modified only by written, fully executed agreement of the parties.

24. Jurisdiction and Venue:

This Contract shall be construed in accordance with the laws of the State of California and the parties hereto agree that venue shall be in Nevada County, California.

25. Compliance with Applicable Laws:

The Contractor shall comply with any and all federal, state and local laws, codes, ordinances, rules and regulations which relate to, concern of affect the Services to be provided by this Contract.

26. Notices:

This Contract shall be managed and administered on County's behalf by the department and the person set forth at §Error! Reference source not found., page one (1) of this Contract, and all invoices shall be submitted to and approved by this Department. A DBE manufacturer is a firm that operates or maintains a factory, or establishment that produces on the premises the materials, supplies, articles, or equipment required under the Contract and of the general character described by the specifications.
- B. If the materials or supplies purchased from a DBE regular dealer, count 60 percent of the cost of the materials or supplies. A DBE regular dealer is a firm that owns, operates or maintains a store, warehouse, or other establishment in which the materials, supplies, articles or equipment of the general character described by the specifications and required under the Contract are bought, kept in stock, and regularly sold or leased to the public in the usual course of business. To be a DBE regular dealer, the firm must be an established, regular business that engages, as its principal business and under its own name, in the

purchase and sale or lease of the products in question. A person may be a DBE regular dealer in such bulk items as petroleum products, steel, cement, gravel, stone or asphalt without owning, operating or maintaining a place of business provided in this section.

- C. If the person both owns and operates distribution equipment for the products, any supplementing of regular dealers' own distribution equipment shall be, by a long-term lease agreement and not an ad hoc or Agreement-by-Agreement basis. Packagers, brokers, manufacturers' representatives, or other persons who arrange or expedite transactions are not DBE regular dealers within the meaning of this section.
- D. Materials or supplies purchased from a DBE, which is neither a manufacturer nor a regular dealer, will be limited to the entire amount of fees or commissions charged for assistance in the procurement of the materials and supplies, or fees or transportation charges for the delivery of materials or supplies required on the job site, provided the fees are reasonable and not excessive as compared with fees charged for similar services.
