SUBJECT:Authorization of Fiscal Year 2019/20 Regional Surface Transportation<br/>Program Funding Requests

**<u>RECOMMENDATION</u>**: Authorize FY 2019/20 Regional Surface Transportation Program (RSTP) funding requests to the Nevada County Transportation Commission (NCTC).

**FUNDING:** The projects for which RSTP funds are being requested are in the Nevada County Department of Public Works Capital Improvement Plan 2019 Annual Update (CIP).

**BACKGROUND:** RSTP funds are Federal Surface Transportation Program funds that are apportioned to specific regions within a state and locally managed and administered by NCTC. Staff is requesting authorization to request RSTP funding from NCTC for four Nevada County projects in FY 2019/20, and to rescind two funding requests from previous years. The following table summarizes Nevada County's requests for RSTP funding in FY 2019/20.

## **RSTP Funding Requests for 2019/20**

As shown above, staff is requesting new allocations for drainage and shoulder maintenance projects, general maintenance projects, and construction inspection for the Donner Pass Road Improvement project. We also recommend that previous allotments totaling \$583,174 for the Combie Road Corridor Improvement Project and \$77,178 for roadway preservation be rescinded. The \$583,174 for Combie Road Corridor will be re-allocated to the upcoming FY, while the roadway preservation projects will be funded by the Road Maintenance and Rehabilitation Account program.

The projects for RSTP funding listed above are consistent with the County's 2019 CIP. Staff requests that the Board approve the attached resolution authorizing the FY 2019/20 RSTP funding applications.
