BACKGROUND:

Currently there are three vacancies on the Agricultural Advisory Commission; Cattle Industry, Farming Industry and Other Agricultural Interests. These vacancies were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers Bulletin Board, in the Board of Supervisors Office, at the Madelyn Helling Library, and on the County website. Notice was also posted at Grass Valley Library, Truckee Library, Truckee Joseph Center, the Truckee Town Hall, and the District V Board of Supervisors office in Truckee.

Mr. Robert Graham, Ms. Aleta Barrett, and Mr. Seth Rosmarin as well as two others submitted applications. All applicants were interviewed by Mr. Chris De Nijs, Agricultural Commissioner, and District IV Supervisor Susan Hoek. Mr. De Nijs and Supervisor Hoek recommend the appointments of Mr. Graham, Ms. Barrett, and Mr. Rosmarin. Also, per the Agricultural Advisory Commission Bylaws Supervisor Hoek and Mr. De Nijs are recommending the redesignation of Ms. Laura Barhydt as the second member representing the Cattle Industry.

Please consider Mr. Robert Graham as a Cattle Industry representative and Ms. Aleta Barrett as a Farming Industry representative; both for unexpired 4-year terms ending March 31, 2022, Mr. Seth Rosmarin as an Other Agricultural Interests representative for a 4-year term ending March 31, 2023, and consider the redesignation of Ms. Laura Barhydt as a Cattle Industry representative, all to the Agricultural Advisory Commission.
