## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION ESTABLISHING A NEVADA COUNTY HISTORICAL LANDMARKS COMMISSION.

WHEREAS, Nevada County has many historical land-marks; and

WHEREAS, these landmarks are fast disappearing and there is a great need to preserve the history of the mine era in Nevada County: and

WHEREAS, it is the intent and desire of the Board of Supervisors to preserve these historical landmarks by the formation of a Commission which will have as its duty and function to designate the historical landmarks and to take whatever steps are necessary to preserve same.

NOW, THEREFORE, BE IT RESOLVED by the County of Nevada, acting by and through its Board of Supervisors, as follows:

- l. There is hereby established a NEVADA COUNTY  ${\tt HISTORICAL\ LANDMARKS\ COMMISSION\ }.$
- 2. That the Commission shall be comprised of five (5) members, one to be appointed by the Board of Supervisors from each supervisorial district and that the members of this Commission shall serve at the will and pleasure of the Board of Supervisors.
