



# RESOLUTION No. 19-384

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION AUTHORIZING AN AMENDMENT TO THE PERSONAL SERVICES CONTRACT WITH BANNER COMMUNICATIONS FOR RADIO SYSTEM MAINTENANCE AND REPAIR AT THE SHERIFF'S OFFICE

WHEREAS, Banner Communications has provided radio system maintenance and repair for the Sheriff's Office since 2014 and these services are essential to the operation of the Sheriff's Office; and

WHEREAS, Resolution 16-272 authorized the execution of a three-year contract with Banner Communications for Sheriff's radio system maintenance and repair for the period of July 1, 2016 to June 30, 2019 with the provision of two additional one-year extensions; and

WHEREAS, Exhibit 'B' of the contract provides for a 3% increase of the base contract amount of \$34,314 for Fiscal Year 2018/19; and

WHEREAS, the parties desire to enter into an amendment to the contract to extend the term of the contract by one year for the period of July 1, 2019 to June 30, 2020, in an amount not exceed \$35,343 for the extension period.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada approves the Amendment to the personal services contract with Banner Communications, entitled Sheriff's Radio System Maintenance and Repair to provide for a 3% increase of the base contract of \$34,314 extending the term of the contract by one year for the period of July 1, 2019 to June 30, 2020 in an amount not to exceed \$35,343, and authorizes the Chair of the Board to execute the amendment on behalf of the County of Nevada.

**AMENDMENT TO CONTRACT WITH**  
Banner Communications

**THIS AMENDMENT** is executed this 7th day of July, 2019 by and between Banner Communication and COUNTY OF NEVADA. Said Amendment will amend the personal services contract between the parties entitled Sheriff's Radio System Maintenance and Repair executed on the 21st day of June, 2016 by Resolution No. 16-272.

**WHEREAS**, Banner Communication is providing radio system maintenance and repair to the Sheriff's Office communication equipment; and

**WHEREAS**, the parties desire to amend their agreement to allow for a one-year extension of the existing contract; and

**WHEREAS**, the agreed-upon cost for the one year extension shall not exceed \$35,343; and


**NOW, THEREFORE**, the parties hereto agree as follows:

1. This amendment shall be effective as of July 1, 2019.
2. That section 2, maximum contract price shall be increased by \$35,343 for fiscal year 2019/20, for a maximum contract price of \$144,343.
3. That section 3, contract termination date shall be extended one year from June 30, 2019 to June 30, 2020.
4. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.


