OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

**RESOLUTION APPROVING A DONATION OF EQUIPMENT
AND SUPPLIES TO GOLD COUNTRY COMMUNITY
SERVICES FOR THE SENIOR FIREWOOD PROGRAM IN
SUPPORT OF THE BOARD OBJECTIVE TO REDUCE THE
RISK OF LOCAL WILDFIRE**

WHEREAS, the Board of Supervisors adopted their 2019 Board Objective in February 2019 through Resolution 19-070. One of the Priority A Objectives is to “Reduce the risk of local wildfire and the effects of wildfire on life, property and the environment by providing leadership and support to community partners, pursuing State and Federal funding, implementing county policies and programs, and assisting the public to be ‘wildfire ready.’ Explore other ways to reduce the threat and damage from wildfires”; and

WHEREAS, in support of this objective the Office of Emergency Services (OES) found that the Gold Country Community Services Senior Firewood Program needed new equipment to continue serving the community; and

WHEREAS, the program accepts donations that are usually in need of cutting, splitting, etc. from properties within 10 miles of Grass Valley. The processing of felled trees and acceptance of wood into the program removes the wood from properties thus reducing fuels on local properties while supporting the senior community with firewood; and

WHEREAS, OES purchased two Husqvarna 28” chainsaws, two Stihl woodcutter kits, two 2.5 gallon fuel cans, two 2.5 gallon Husqvarna mix oil, one case Husqvarna bar oil, four 28” saw chains, two wheelbarrows, two set of gloves, two 20x40 tarps, and two fire extinguishers for a total cost of \$2,828.58; and

WHEREAS, these purchases were made from two local vendors: A to Z and SPD Saw Shop. To support Board Priority Objective A and our community partner Gold Country Community Services OES is requesting to donate these items to the Senior Firewood Program.

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of the County of Nevada, State of California, hereby approves the donation of equipment and supplies in the amount of \$2,828.58 to the Gold Country Community Services organization for use in the Senior Firewood Program in support of a Priority A 2019 Board Objective to reduce the risk of wildfire.
