Honorable Chair and Board Members:

At our June 21, 2019 meeting, the Nevada County Historical Landmarks Commission voted unanimously to recommend to the Board that the Town of Truckee's application for landmark designation of a plaque commemorating the historic Lake Tahoe Railway be approved and the plaque designated as Nevada County Historical Landmark NEV 19-03.

The Lake Tahoe Railway & Transportation Company was instrumental in the development of the Lake Tahoe Area. It operated from 1900 to 1943. The line ran from the Southern Pacific Depot in Truckee, 15 miles south to the shores of Lake Tahoe. There it met the steamer SS Tahoe, which traveled to lakeside locations. A plaque commemorating the Railway was vandalized many years ago. This replacement is being dedicated with the cooperation of the Union Pacific Railroad.

The applicant has provided a thorough level of research and documentation to accompany the application, which has been reviewed by the Commission for historical accuracy. The application and supporting documentation are enclosed.

Brief history and description of proposed landmark: (Attach additional sheets as necessary)

Just south of the transcontinental railroad tracks, lay the tracks of The Lake Tahoe Railway & Transportation Company, which was instrumental in the development of the Lake Tahoe Area. Incorporated in December 1898 by Duane Leroy Bliss, its narrow gauge railroad opened for seasonal traffic on May 1, 1900. The line ran from the Southern Pacific Depot in Truckee, 15 miles south to the shores of Lake Tahoe. Tahoe City hosted the railroad's shops. The train met the Bliss steamer *SS TAHOE* at the Tahoe Tavern Hotel and pier, which then travelled to lakeside locations. Southern Pacific purchased the line and converted it to standard gauge in 1926. Passenger service operated until abandonment in November 1943.

Unique aspects or properties of proposed landmark.

The LTRTCo. is unique in that it was at the intersection of the main transcontinental Southern Pacific rail line and the route from Truckee to Lake Tahoe which brought world-wide attention to the area as a tourist destination.

How will the landmark be protected and maintained?

As there are two other landmark designations in the same general area (Theodore Dehone Judah dedication plaque, ECT 25, and the First Transcontinental Railroad Truckee plaque, CHL 780-6), the Town of Truckee will maintain this plaque in the public area of the Truckee Train Depot with coordination from the Truckee Donner Railroad Society.


