**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**  
**RESOLUTION ADOPTING THE INITIAL STUDY/MITIGATED**  
**NEGATIVE DECLARATION FOR THE HIRSCHDALE ROAD**  
**BRIDGES PROJECT – DISTRICT 5**

WHEREAS, the Nevada County Department of Public Works proposes to replace the existing structurally deficient Truckee River Bridge on Hirschdale Road over the Truckee River with a two-span, approximately 283-foot-long by 26-foot-wide, cast-in-place concrete box girder or precast concrete girder with cast-in-place concrete deck accommodating one 16-foot travel lane and a 6-foot sidewalk and bridge railings, to meet current safety and structural standards; and

WHEREAS, the Nevada County Department of Public Works proposes to rehabilitate and seismically retrofit the Hirschdale Road Overhead bridge, with final dimensions of 19 feet wide accommodating a 15-foot-wide travel lane and bridge railings, to meet current safety and structural standards; and

WHEREAS, the Nevada County Department of Public Works has determined that the project is subject to the provisions of the California Environmental Quality Act (CEQA), and acting as the lead agency has prepared an Initial Study/Mitigated Negative Declaration (IS/MND); and

WHEREAS, the IS/MND was circulated for public review and comment for 30 days in accordance with Public Resources Code section 15105, and the Notice of Intent to adopt the IS/MND was duly published and posted as provided in Section 15072 of the CEQA Guidelines; and

WHEREAS, the IS/MND has concluded that although the project could have a significant effect on the environment, there will not be a significant effect in this case because mitigation measures have been incorporated by the project proponent which reduce said potential impacts to a less than significant level.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors hereby finds and determines as follows:

1. That the above recitals are true and correct.
2. That amended Mitigation Measures AIR-2(c) and NOISE-1(e) and new Mitigation Measure REC-1 are equivalent to or more effective in mitigating or avoiding potential significant effects and that in themselves will not cause any potentially significant effect on the environment.
3. That the Board has received and considered the proposed Initial Study/Mitigated Negative Declaration attached hereto as Exhibit A together with all comments received during the public review process.
4. That, based on the entire record before the Board, there is no substantial evidence that the proposed project might have any significant adverse impact on the environment.

5. That the proposed Mitigated Negative Declaration reflects the independent judgment of the Board of Supervisors.
6. That the location and custodian of the documents which constitute the record of these proceedings is the Nevada County Department of Public Works, 950 Maidu Avenue, Nevada City, California.

BE IT FURTHER RESOLVED that the Board of Supervisors hereby adopts the Initial Study/Mitigated Negative Declaration attached hereto as Exhibit A, and directs the Director of the Nevada County Department of Public Works to file a Notice of Determination with the Nevada County Clerk and the California State Clearinghouse within five (5) days from the date of this action.
