SUBJECT: Resolution Authorizing the Purchase of a Capital Asset of One (1) Fixed Position Digital Security Camera System from ICU Technologies, Inc., Through GSA Contract No. 47QSWA18D003K for Installation at Tinloy Transit Center, Including: One Network Video Recorder, Eight Digital Fixed Mount Cameras and Associated Enterprise Camera Licenses and all Associated Installation Costs in the Amount of \$35,307.47

RECOMMENDATION: Approve the attached Resolution.

FUNDING: Funding for this Capital Asset, in the amount of \$35,307.47, is provided through Fiscal Year 2014/15 Proposition 1B, California Transit Security Grant Program – State Transit Assistance Fund (CTSGP-CTAF) funds (70700006) and is included in the FY 2019-20 Transit Services budget. No budget amendment is required. There is no impact to the County's General Fund.

BACKGROUND:

The Transit Services Division, through multiple Proposition 1B, California Transit Security Grant Program – State Transit Assistance Fund (CTSGP-CTAF) grants, has developed a multi-phased, bus-stop improvement, and system security enhancement program designed to improve overall consumer access and system safety.

On May 24, 2016, the Nevada County Board of Supervisors approved Resolution 16-492, accepting the award of Fiscal Year 2014/15 Proposition 1B, California Transit Security Grant Program – State Transit Assistance Fund (CTSGP-CTAF) funds in the amount of \$72,167.

The proposed purchase supports the Transit Technology Solutions effort, and is consistent with the CTSGP-CTAF Bus Stop safety and security improvement grant program, and is included in the FY 2019-20 Transit Services Division Annual Budget.

The purchase of the ICU Technologies, Inc., Network Video Recorder, eight digital security cameras and associated camera licenses, via General Services Administration (GSA) contract No. 47QSWA18D003K, are a part of a project to upgrade and enhance the security camera system at the Tinloy Transit Center. The system upgrade will enhance camera optics, upgrade video recording capabilities, support eight (8) fixed location cameras, and will tie directly into the Grass Valley Police Department, creating a vastly enhanced security system at the County's major Transit Hub.

It is recommended that the Board of Supervisors adopt a resolution approving the release of Fiscal Year 2014/15 Proposition 1B, CTSGP-CTAF fund balance and the purchase of this capital asset.
