
RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE HOUSING PRESERVATION GRANT (HPG) AGREEMENT WITH THE U.S. DEPARTMENT OF AGRICULTURE (USDA), RURAL DEVELOPMENT TO EXTEND THE AGREEMENT TERM THROUGH SEPTEMBER 30, 2020 (RES. 18-487)

WHEREAS, per Resolution 18-487, the County entered into an Agreement with the U.S. Department of Agriculture, Rural Development, for Section 533 HPG program funding for the term of September 30, 2018 through September 30, 2019 in the amount of \$68,928.25; and

WHEREAS, the Board of Supervisors of the County of Nevada desires to improve the living conditions of its low and very low-income residents who are in need of repairs or rehabilitation to their housing; and

WHEREAS, this Amendment will extend the termination date of the grant agreement from September 30, 2019 to September 30, 2020, as the Health and Human Services Agency – Housing and Community Services Division is committed to working with our community partners to fully expend these funds by September 30, 2020, in order for our community to receive the maximum benefits offered under the HPG Program.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment to the 2018 Housing Preservation Grant (HPG) Agreement by and between the County and the U.S. Department of Agriculture, Rural Development, which extends the ending date of this Agreement from September 30, 2019 to September 30, 2020, be and hereby is approved in substantially the form hereto attached, and that the County Executive Officer be and is hereby authorized to execute the Amendment and any subsequent amendments on behalf of the County of Nevada.
