This board governs the County law library and was established under the provisions of Chapter 52 of the Business & Professions Code. The law library is maintained by a seven member Board of Trustees.

The judges shall elect either four or five of their number to serve as trustees, and any judge who is elected as trustee, at that judge's option, may designate a resident of the County or member of the State Bar to act for judge as trustee. The Chair of the Board of Supervisors is the Ex-Officio Trustee and may appoint a member of the State Bar, any other member of the Board of Supervisors, or a resident of the County to serve as trustee in place of the Chair. However, at the request of the Chair, the Board of Supervisors may appoint a member of the State Bar, any other member of the Board of Supervisors, or a resident of the County to serve as trustee in place of the Chair. The Board of Supervisors shall appoint as many additional trustees, who are members of the State Bar, as may be necessary to constitute a board of at least six and not more than seven members. The Board of Supervisors, at any meeting in January, shall appoint trustees to serve the term of one year. No more than two law library trustees may be residents of the County who are not judges of the County, members of the State Bar, or members of the Board of Supervisors of the County.
