# OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE SUBMITTAL OF AN APPLICATION FOR FUNDING AND THE EXECUTION OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO PERTAINING TO THE 2019/2020 FUNDING YEAR OF THE STATE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

WHEREAS, the California Department of Housing and Community Development (HCD) announced the availability of approximately \$60 million in funding for the Community Development Block Grant (CDBG) Program representing funding for the 2019-2020 program years; and

WHEREAS, the CDBG application is due April 15, 2020, and the Health and Human Services Agency (HHSA) wishes to apply for funding; and

WHEREAS, this CDBG funding is for various programs including Public Services, and Housing Programs; and

WHEREAS, upon authorization and approval by the Board of Supervisors HHSA will prepare and submit an application in the amount of up to \$1,979,500; and

WHEREAS, upon receipt of a grant agreement, the Director of Health and Human Services will return to the Board of Supervisors for acceptance of the grant, at which time the Director of Health and Human Services, or designee, sign the standard agreement with the State of California for the purposes of this grant.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, authorizing the submittal of one or more application(s) in the aggregate amount of \$1,979,500 for the following CDBG activities, pursuant to the January 2020 CDBG NOFA and the Board authorizes as follows:

#### **SECTION 1:**

# **SECTION 3:**

The County hereby authorizes and directs the Director of Health and Human Services, to sign this application and act on the County's behalf in all matters pertaining to this application.

## **SECTION 4:**

If the application is approved, the Director of Health and Human Services, or designee, is authorized to enter into and sign the grant agreement and any subsequent amendments thereto with the State of California for the purposes of this grant.

#### **SECTION 5:**

Upon receipt of a grant agreement, the Director of Health and Human Services will return to the Board of Supervisors for acceptance of the grant, at which time the Director of Health and Human Services, or designee, sign the standard agreement with the State of California for the purposes of this grant.

## **SECTION 6:**

If the application is approved, the Director of Health and Human Services or designee, is authorized to sign Funds Requests and other required reporting forms.
