### **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

**RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT WITH ST. HELENA HOSPITAL DBA ADVENTIST HEALTH VALLEJO ("CONTRACTOR") FOR THE PROVISION OF ACUTE PSYCHIATRIC INPATIENT HOSPITALIZATION SERVICES TO: 1) REVISE EXHIBIT "A", "SCHEDULE OF SERVICES", TO INCLUDE UPDATED LANGUAGE; 2) REVISE EXHIBIT "B", "SCHEDULE OF CHARGES AND PAYMENTS", TO REFLECT THE UPDATED RATE STRUCTURE; 3) REVISE EXHIBIT "C", "SCHEDULE OF CHANGES" AND 4) REVISE EXHIBIT "D", "SCHEDULE OF HIPAA PROVISIONS" (RES. 19-368)**

WHEREAS, Contractor provides psychiatric inpatient hospital services to county clients as referred and authorized for services by Nevada County Behavioral Health Department; and

WHEREAS, on July 9, 2019, per Resolution 19-368, the Nevada County Board of Supervisors authorized the execution of the Renewal Personal Services Contract between the County of Nevada and St. Helena Hospital dba Adventist Health Vallejo pertaining to services for medically necessary inpatient services to eligible residents of Nevada County who have a mental illness and / or emotional disturbances that require acute psychiatric hospitalization services; and

WHEREAS, the parties desire to amend the Personal Services Contract to include updated language and rate structure for services.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to the Personal Services Contract by and between the County and St. Helena Hospital dba Adventist Health Vallejo pertaining to the provision of acute psychiatric inpatient hospitalization services for County referred clients to revise Exhibit "A" Schedule of Services, to include updated language; to revise Exhibit "B" Schedule of Charges and Payments, to reflect the updated rate structure and reflect the maximum amount of \$50,000 for the contract term of July 1, 2019 through June 30, 2021; to revise Exhibit "C" Schedule of Changes, and to revise Exhibit "D" Schedule of HIPAA Provisions, be and hereby is approved as attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Contract on behalf of the County of Nevada.
