The amendments include the following:

1) Increase the number of allowed events from four (4) to eight (8) per year; 2) Modify the permit issuing agency to the Community Development Agency from the Nevada County Sheriff's Office; 3) Provide clarification of sanitation requirements for portable toilets; 4) Remove the requirements for criminal record checks, security posting and proof of insurance; 5) Clarify the appeal and violation procedures.

The meeting will be held remotely, according to Governor Newsom's Executive Order <u>N-25-20</u> dated March 12, 2020, which provides direction on holding public meetings during the COVID-19 pandemic, in addition to social distancing guidelines as outlined by the Nevada County Public Health Department. The Board of Supervisors will attend the meeting and participate remotely to the same extent as if they were present.
