We are pleased to inform you that the Rüdiger Foundation (RuF) has approved your grant of \$38,200 for the acquisition of a K9 Officer for the Nevada County Sheriff's Department (NCSO). These grant funds are to be used specifically for the acquisition and outfitting of a K9 Officer and will be dispersed upon qualifying receipts provided by the NCSO. This grant approval covers the attached funding request, and will be in place for the term of one year from the date of this letter. RuF will consider, contingent upon funding, requests for ongoing training costs and other one-time expenditures on a case-by-case basis beyond the terms of this grant period and maximum grant award. Any application for ongoing training and one-time expense grants will be reviewed annually as part of the Rüdiger Foundation annual budget. - 2. Upon reimbursement of expenses, written acknowledgment of receipt funds will be provided to RuF.
- 3. Cooperate with efforts of the Rüdiger Foundation to publicize the grant award.
