SUBJECT:	Resolution accepting funds from the California Department of Social Services, Housing and Disability Advocacy Program (HDAP) to be used for the Nevada County Housing and Disability Advocacy Program (HDAP) in the amount of \$150,000 available through June 30, 2020 and Authorizing and Directing the Auditor-Controller to amend the Social Services Budget for Fiscal Year 2019/20. (4/5 vote required) (RES. 18-093; RES. 18-167)

**<u>RECOMMENDATION</u>**: Approve the attached Resolution.

**FUNDING:** The HDAP program is funded with monies appropriated through the State of California 2019 Budget Act. This funding requires a 100% county match contribution, for a total base grant amount of \$300,000. Previously, HDAP funding required a cash match but statutory changes in the most recent program guidance allowed for in-kind match. All necessary in-kind match has been identified. A budget amendment is included and requires a 4/5 vote by the Board Members. There are no county general fund dollars required in the Agreement.

**BACKGROUND:** The Department of Social Services has secured funding made available through the California Department of Social Services (CDSS). This funding was initially one- time funding appropriated in the 2017-18 state Budget Act. In the 2019 Budget Act, the program was granted 25 million in ongoing funding that supports the HDAP programs statewide.

Per Resolution 18-093 and 18-167, the Board of Supervisors accepted

noncompetitive and competitive funds in the amount of \$151,062 to implement and integrate HDAP into the County's Continuum of Care, offering disability advocacy, outreach and housing assistance to vulnerable county residents.

For Fiscal Year 19/20, the County has been allocated an additional \$50,000 in noncompetitive HDAP funding and also awarded an HDAP augmentation of \$100,000. This additional funding allows the County to continue to fund the Program through its contracted partnership with FREED – Center for Independent Living.
