## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF THE STANDARD AGREEMENT NO. 20-HHAP-00028 BETWEEN THE STATE OF CALIFORNIA BUSINESS, CONSUMER SERVICES, AND HOUSING AGENCY'S HOMELESS COORDINATING AND FINANCING COUNCIL AND THE COUNTY OF NEVADA TO PROVIDE \$452,905 IN FUNDING TO SUPPORT COUNTY STRATEGIC OBJECTIVES TO ADDRESS HOMELESSNESS IN THE REGION AND AUTHORIZING AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE HEALTH AND HUMAN SERVICES AGENCY HOUSING AND COMMUNITY SERVICES DIVISION'S BUDGET FOR FISCAL YEAR 2019/20 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, on July 31, 2019, Governor Gavin Newsom signed AB 101, providing 8 billion dollars in State funding to address housing and homelessness in California; and

WHEREAS, Chapter Six of Part 1 of Division 31 of the Health and Safety Code, commencing with section 50216, establishes the Homeless Housing, Assistance and Prevention Program (HHAP) allocating \$650 million to Counties and Continuum of Care organization across the state; and

WHEREAS, the Nevada County portion of this funding is \$452,905 to be spent on eligible uses as outlined in the HHAP program guidelines; and

WHEREAS, Nevada County has met all requirements set forth in HHAP program guidelines to be awarded these funds to be used to address critical needs to combat homelessness in the County.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Standard Agreement Number 20-HHAP-00028 by and between the County of Nevada and the State of California Business, Consumer Services, and Housing Agency's Homeless Coordinating and Financing Council, providing the County of Nevada \$452,905 in funding to be used for eligible activities to support strategic objectives to address homelessness in the region as described in the County's application hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors authorizes the Director of Child Support Services/Collections and Housing & Community Services to execute the Agreement on behalf of the County of Nevada.

BE IT FURTHER RESOLVED that the Auditor-Controller is authorized and directed to amend the Health and Human Services Agency Housing and Community Services Division's Budget for Fiscal Year 2019/20 as follows:
