### **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

**RESOLUTION APPROVING GRANT AGREEMENT NUMBER 19-10866 WITH THE CALIFORNIA DEPARTMENT OF PUBLIC HEALTH (CDPH) DIVISION OF COMMUNICABLE DISEASE CONTROL (DCDC) FOR ONE-TIME FUNDING TO ADDRESS INFECTIOUS DISEASE PREVENTION AND CONTROL IN THE MAXIMUM AMOUNT OF \$165,125.61 FOR THE TERM OF FEBRUARY 1, 2020 THROUGH JUNE 30, 2023 AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE HEALTH AND HUMAN SERVICES AGENCY PUBLIC HEALTH DEPARTMENT BUDGET FOR FISCAL YEAR 2019/20 (4/5 AFFIRMATIVE VOTE REQUIRED)**

WHEREAS, under this Agreement, the State of California's Department of Public Health (CDPH) Division of Communicable Disease Control (DCDC) is providing one-time funds to address infectious disease prevention and control within the County of Nevada; and

WHEREAS, Nevada County Public Health employs a variety of intensive strategies, including, but not limited to, targeted outreach and education to at-risk communities and health care providers, disease investigation and contact tracing, and epidemiological surveillance.

WHEREAS, the purpose of this award is to bolster local public health infrastructure to support additional communicable disease investigation activities including disease surveillance and documentation, monitoring and evaluation of disease-specific prevention activities, and surge activities in response to local outbreaks.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the award from the State of California's Department of Public Health to the County's Public Health Department in the maximum amount of \$165,125.61 for disease prevention and control for the term of February 1, 2020 through June 30, 2023, be and is hereby approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Agreement on behalf of the County of Nevada and directs the Auditor-Controller to amend Health and Human Services Agency Public Health Department budget as follows:
