RESOLUTION APPROVING AMENDMENT NO. 2 TO THE MEMORANDUM OF UNDERSTANDING WITH THE COUNTY OF BUTTE FOR PROVISION OF MALE COMMUNITY REENTRY PROGRAM COORDINATION SERVICES TO EXTEND SERVICES THROUGH FISCAL YEAR 2019-2020

WHEREAS, the California Department of Corrections and Rehabilitation (CDCR) allows eligible inmates committed to State Prison, who have approximately 180 days to 30 days prior to the Earliest Possible Release date (EPRD), to serve their sentences in the community in lieu of confinement in State prison; and

WHEREAS, Nevada County desires to provide reentry program services to eligible inmates; and

WHEREAS, Nevada County does not have a reentry program and is desirous of contracting with Butte County to provide Male Community Reentry Program (MCRP) services to Nevada County participants; and


WHEREAS, Butte County has executed a contract with CDCR, Division of Rehabilitative Programs (DRP), to deliver a MCRP.

WHEREAS, Butte County's MCRP provides or arranges linkages to a range of community-based rehabilitative services which assist with substance abuse disorders, mental health care, employment, education, housing, family reunification and social support; and

WHEREAS, Butte County agrees to provide MCRP services, at no cost, to participants convicted to State Prison whose County of Last Legal Residence (CLLR) was Nevada County; and

WHEREAS, the parties have previously entered into a Memorandum of Understanding dated January 1, 2017 which is set to expire on June 30, 2019 adopted by Resolution 17-135 and amended by Resolution 18-377.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors, of the County of Nevada, State of California, approves the Amendment No. 2 to the Memorandum of Understanding between County of Nevada and County of Butte to extend services through Fiscal Year 2019/2020, and authorizes the Chair of the Board of Supervisors to execute the Amendment on behalf of the County of Nevada.
