Honorable Chair and Board Members:

At today's meeting of the Nevada County Historical Landmarks Commission, the Commission voted unanimously to recommend to the Board that the application for landmark designation of a plaque commemorating Ellen Clark Sargent be approved. Applicants are The Native Daughters of the Golden West, the Daughters of the American Revolution and The Nevada County Historical Society. The plaque is to be placed in Calanan Park, and Nevada City, which owns the park, has approved the placement. It is to be designated as Nevada County Historical Landmark NEV 20-03.

This year marks the 100th anniversary of the enactment of the 19th Amendment to the U.S. Constitution giving women the right to vote. That amendment was in a sense born in Nevada County, by the efforts of Ellen Sargent, prominent suffragist, and her husband, U.S. Senator Aaron Sargent. A leader in the fight for women's right to vote, she founded the Nevada County Woman's Suffrage Association in 1869. She was the President of the California Woman Suffrage Association and Treasurer of the National Woman Suffrage Association. Her tireless work resulted in California women winning the right to vote in 1911.

The applicants have provided a thorough and compelling level of research and documentation to accompany the application, which has been reviewed by the Commission for historical accuracy. The application and supporting documentation is enclosed.

If you approve the application, please forward the resolution and accompanying documents to the County Recorder.



If you have any further questions do not hesitate to contact me. I should mention that there is some urgency to proceeding. We would like to unveil the plaque at an appropriate ceremony on August 20, the 100th anniversary date. Because of the pandemic, our plaque supplier has been forced to reduce its staff and consequently its output. Accordingly, the sooner this application is processed, the more likely the plaque will be ready for the ceremony.

Brief history and description of proposed landmark: The plaque will be placed on an existing stone in Calanan Park. The park is owned by the city of Nevada City, which has approved the placement of the plaque in the park. The plaque will honor Ellen Clark Sargent, a prominent suffragist who was an important advocate for woman's suffrage at the local, state, and national level. She arrived in Nevada City in 1852, joining her husband Aaron A. Sargent who had arrived in the city in 1849. Ellen's advocacy of the woman's suffrage movement spanned much of her adult life, from the late 1860s until her death on July 13, 1911. Susan B. Anthony was a close friend of Ellen, and a frequent guest in the Sargent homes in California and Washington D.C. Ellen was associated with many of the important local, regional and national suffrage organizations. Regrettably, Ellen died three months before California voted to grant women the right to vote in the election of October 10, 1911.

Ellen's political activism in Nevada City included the formation of the Nevada County Woman's Suffrage Association in 1869. The organization included many of the prominent women of the city. The organization's activities cannot be associated with any particular location(s) in Nevada City as the meetings were held at the homes of at least six of the members, and at several different public buildings, some of which no longer exist. But most of their group's meetings were held in the downtown area. The night before the California election on October 10, 1911, a grand rally was held as the crowd processed through the streets down to the bottom of Broad Street for speeches and music. Calanan Park would provide a central focus for the woman's suffrage movement locally, and for Ellen Clark Sargent's contributions to it.

Unique aspects or properties of proposed landmark: This will be the only plaque in Nevada County to honor Ellen Clark Sargent, the Suffrage movement and the passage into law of the 19th Amendment on August 20, 1920.

How will the landmark be protected and maintained? The Public Works Department of Nevada City will maintain the landmark.

TITLE: Plaque Honoring Ellen Clark Sargent at Calanan Park

<u>RECOMMENDATION:</u> Provide staff direction on an application by the Nevada County Historical Society to install a plaque honoring Ellen Sargent at Calanan Park.

<u>BACKGROUND / DISCUSSION:</u> Due to PG&E Public Safety Power Shutoffs this item was continued from the October 23, 2019 City Council meeting which was adjourned due to lack of quorum from the shutoffs.

The Nevada County Historical Society has submitted an application to place a plaque in an existing granite form at Calanan Park. The plaque will honor Ellen Clark Sargent's contribution to the women's suffrage movement. Additional information on Sargent's contribution is attached.

The City has an adopted application procedure for installing historic plaques, as well as a procedure for placing artifacts on City property. The two procedures are similar for plaques installation in terms of requiring a bronze-like appearance, and specifying the exact wording. The procedure for placing items within city property also requires that the applicant list efforts undertaken to gather public opinion and community support. To that end, the applicant indicated that the effort is being backed by the Daughters of the American Revolution, the Daughters of the Golden West, and the Nevada County Historical Society. Staff also reached out to Miriam Morris, the park's unofficial caretaker, who has indicated support for the project (see email attachment). Staff is seeking direction for whether or not any additional effort by the applicant is recommended to gather community support.

<u>PLAQUE DESIGN</u>: The plaque will be similar in design style to the one mounted on 309 Broad Street (Golden Era), but will feature text honoring Sargent:

ELLEN CLARK SARGENT (1826-1911)

Prominent -Suffragette

A longtime resident of Nevada City and founder of the Nevada County Woman's Suffrage Association in 1869. President of the California Woman Suffrage Association. Treasurer of the National Woman Suffrage Association. Led the campaign that secured California women the right to vote in 1911. Inspired the 19th amendment to the U.S. Constitution, which had been introduced by her husband, Senator Aaron A. Sargent, in 1878 and enacted on August 20, 1920.



Calanan Park and Nevada City's 'Bronze Jungles'

BEGINNING in the decade of the 1960s, Nevada City became increasingly aware of its responsibility to protect and preserve its most valuable historic resource – the town itself. Farsighted city councils and staff members aided by interested residents banded together to pass ordinances protecting the architectural integrity of the 19th century while providing for the necessary 20th and 21st century health and safety innovations. These assurances guarantee that future generations will be able to enjoy Nevada City's unique place in California Gold Rush history. The resulting transformation has reshaped the downtown core area into a shopping and sightseeing mecca for visitors and tourists worldwide. Nevada City is regarded as the finest example of a preserved – not restored, or rebuilt – Gold Rush community anywhere in California. It has been featured in travel articles in both the national and international press. A positive side effect is the seemingly endless placement of markers pointing out this or that fact about the town, its history or its buildings. Many of the downtown structures have been marked by E Clampus Vitus No. 10, as part of that group's ongoing history preservation project.

CALANAN PARK – This little spot of "green" was given to the city by the United States Department of the Interior in 1971. It had been used as a park for many years prior to its official acquisition and, like Robinson Plaza was named for a city official, George Calanan, the city clerk who for many years assumed the role of city manager even though there was no such office. He was also a member of the board of directors of the Nevada County Narrow Gauge Railroad and was appointed receiver when the road entered bankruptcy. "Mr. Nevada City," as he was called, died in Nov. 1951 at age 79.

Today, the park is filled with all manner of relics from a hydraulic mining nozzle, to an ore car, a gate valve, an experimental drill core ... all except the ore car, are dutifully plaqued; there is little room for many more artifacts. Paved pathways meander through the area and low rock and brick walls provided seats for park denizens. There are even sections of steel bridge railing separating pedestrians from planted areas. Landscaping is quite mature and consists in part of laurel, holly, a type of cypress, annual and perennial plantings in addition to the town's somewhat ailing white fir Christmas tree. However, in the wings ready to assume the town tree mantle is a tall, double-headed coast redwood (Sequoia sempervirens) standing north behind the fir.

Let's take a look at the bronze plaques in the park. The first was placed "In memory of the pioneers of Nevada City. Dedicated August 21, 1963 by the Nevada City Woman's (sic) Club." This small tablet is on top of the wall facing Broad Street, near the hydraulic gold mining monitor which artifact was dedicated as "Historic," on Nov. 11, 1965, by Hydraulic Parlor No. 56, Native Sons of the Golden West

The plaque briefly outlines the hydraulic process which was the most destructive of all the methods used to mine gold. The name "Monitor," was originally a trade name for a particular brand of nozzle, but became generic with use. The force of water leaving the nozzle was great enough to disintegrate a 3-foot thick brick wall at a distance of 50 feet!

North, behind the monitor is a 21-inch gate valve with an interesting past, one that pairs it with the monitor. Again, the green painted, steel railing is from the demolished Gault Bridge, built in 1903, that crossed Deer Creek on South Pine Street. The replacement bridge, built in 1996, is a faithful representation of the Gault.

A stainless steel drinking fountain with plaque and monument was donated by the Nevada City Lions Club. It is a memorial to three of the club's deceased members, "who gave 114 years of service to our city," and stands beyond the gate valve.

The most unusual artifact in Calanan Park is found facing Union Street, originally called Union Alley. It is truly a unique piece of gold mining history, an experimental shaft drill core from the Idaho-Maryland Mine. This work was done in 1935-36.

South of the drill core, mounted on a granite slab, is a plaque to Nevada City itself, to its National Register of Historic Places status. Placed by the Native Sons of the Golden West No. 56, Sept. 23, 1985.

Next year, 2020, will be the 100th anniversary of the passage of the 19th Amendment to the US constitution, granting women the right to vote. Nevada County was the birthplace of the Amendment, as its parents were Aaron and Ellen Sargent. Much is known about Aaron, one of the most prominent sons of Nevada County: publisher, politician, Congressman, Senator and Ambassador. Much less is known about Ellen, one of the most prominent daughters of Nevada County. This is her story.

Ellen Clark was born in Massachusetts in 1826. As a teenager in Newburyport Massachusetts, she fell in love with Aaron Augustus Sargent, one year her junior, an aspiring journalist and politician. Both taught Sunday school in the local Methodist Church. ¹

In 1847 Aaron left Ellen to begin the journey which in 1849 brought him to Nevada City to search for gold. He built a four room house on Broad Street and in early 1852 returned to Newburyport where he and Ellen were married on March 15. They arrived in Nevada City that October. Ellen wrote of her arrival:

"My good husband had before my arrival provided for me a one story house of four rooms including a good sized pantry where he had already stored a bag of flour, a couple of pumpkins and various other edibles ready for use." ²

While Aaron prospered in business, politics and the law, Ellen raised three children, daughters Ellen (b. 1854) and Elizabeth (b. 1857) and son George (b. 1860). She was always an advocate of women's rights and in

1869 founded the Nevada County Woman's Suffrage Association. Soon ³ afterward, she became president of the California Woman Suffrage

Association. In 1869, Susan B. Anthony and Elizabeth Cady Stanton ⁴ founded the National Woman Suffrage Association, to advocate for a constitutional amendment granted women the right to vote. Ellen soon ⁵ became its treasurer. ⁶

Susan B.Anthony was a close friend of Ellen's, and a frequent guest in the Sargent homes in California and Washington D.C. A sense of the depth of their relationship can be gleaned from the over 30 years of correspondence between them.

For example, In 1872, Aaron was elected to the United States Senate and the Sargent family moved to Washington. Susan accompanied the Sargent family on their trip across the country. In Wyoming, the train stalled in a snowstorm. Wrote Susan:

"...young Georgie Sargent got out to explore, slipped on the snow and broke his arm. Watching the painful bone-setting of her little son's arm, Ellen fainted." ⁷

Ellen lived in Washington on and off, for 12 years. When Aaron was appointed Minister to Germany, she accompanied him to Berlin. She ⁸ enjoyed her time in Europe, and the ministerial life, though she candidly wrote George:

"...I expect to go to the Court Entertainment of January 19. Your mother

will appear in a dress decollete, without sleeves, such is the tyranny of court fashion, but still, it seems best that I should go. Of course, I can stay away, but if I go I must conform to the custom". ⁹

Upon her return to the US, she wrote Susan:

"I assure you it seems great to be once more on American soil, and I believe myself to have a more just appreciation of my country since my sojourn in foreign lands. We are far from being a perfect people or a perfect government, but it seems to me there is more hope of our growing to the full stature of men and women here, than of those who are under the conditions of the old world". ¹⁰

Aaron died in 1887. Susan immediately sent her condolences:

"Where is the man who will do publicly - what your noble husband did so bravely for the cause of women during the terms of his congressional life". ¹¹

Ellen replied:

"I have thought often of you, but a multiplicity of cares and my depression of spirits at the loss of my dear husband has prevented me from writing to you. We are gradually returning to our normal tone of feeling and to the duties of everyday life, for we must go on with living however dearest friends may drop from our sight. It seems to me like a fearful dream all the time. I don't know that I want any more of life for myself, but my family and friends still hold me, and I am always hoping that I may still do a little for the world that it may be some better for my having lived in it." ¹²

Ellen returned to San Francisco, where the Sargents had bought a home before he was elected to the Senate. She continued her activities with the California Woman Suffrage Association and the National American Women

Suffrage Association. She also helped found the Century Club, San ¹³ Francisco's first woman's club, still in existence. ¹⁴

Ellen and Susan continued to correspond. Over the years, Ellen shared some of her doubts and concerns:

"How is it with our countrywomen? Have we any influence at all in shaping the legislature of this country? Have we any power hidden or acknowledged? In short have women anything to do with the present campaign? Will anybody do anything for us? Will we do anything for

ourselves?" 15

Somewhat later, Ellen wrote:

I wish Mr. S. could go to Washington and do for the woman what Sumner did for the colored man. Oh it seems to me we must come to our time soon. "Watchwoman what of the night"? What of the dawn?" ¹⁶

Susan often gave advice:

"You need a score of good organizers... in as many different counties every single day - but while you may not find organizers - you must be able to find good canvassers with the petitions - it needs intelligent women — who can give the reasons for our position - paid agents as a rule - aren't good for much — because they do not understand the great principles upon which our claim rests." ¹⁷

When Ellen was preparing a suffrage petition, Susan cautioned:

I think it's stronger not to say "woman" or "sex" –just Equal suffrage – and "Citizenship the basis of suffrage." ¹⁸

This organization resulted from a merger of the American Woman Suffrage Association with ¹³the National Woman Suffrage Association.

At the age of 74, Ellen became a tax protester. Her position was simple: why should she have to pay taxes to a government that wouldn't let her

vote. She lost her court case, but continued to file tax protests. Her ^{19 20} actions caused other wealthy women taxpayers to also protest. Finally in 1911, she led the campaign for a successful California referendum which amended the California constitution to give women the right to vote. ²¹

Ellen died during the referendum campaign. The City of San Francisco held its first public memorial for a woman, during which it was said: "It was her strong conviction that the ballot, in the hands of women, would help to redeem the world." State flags were flown at half-mast. ²² ²³

In 1878, Aaron while a U.S. Senator had proposed a constitutional amendment giving women the right to vote, It got nowhere for 40 years. It was reintroduced in 1919 and enacted in 1920 as the 19th Amendment to the US Constitution. It is Ellen's eternal memorial.
