Notice is hereby given that the Nevada County Board of Supervisors will hold a special meeting on Tuesday, June 2, 2020, beginning at 9:00 a.m. in the Board Chambers, First Floor, Eric Rood Administrative Center, 950 Maidu Avenue, Nevada City, California, for the purpose of hearing written and oral comments from the public concerning the proposed Final Budget for Fiscal Year 2020/21 totaling approximately \$266,002,423.

The Board Chair may place reasonable restrictions on the time allowed to any person to comment on these matters. Any person commenting on behalf of an organization or group who wishes additional time must have a written statement signed by an officer of that organization stating that he/she is authorized to speak on behalf of that body, and that he/she is relaying the majority thinking thereof.
