Four Items for Consideration

- 1. Permanent Local Housing Allocation Plan and Authorization of PLHA Application (Two Separate Resolutions)
- 2. Memorandum of Understanding Between County of Nevada, City of Grass Valley and City of Nevada City for Regional Partnership re: PLHA and Local Housing Trust Fund (LHTF)
- 3. Authorize Submission of LHTF Application



Background:

 PLHA: created by the 2017 Building Homes and Jobs Act – a.k.a SB2

- SB2 established a \$75 recording fee on certain real estate documents
- These funds provided a permanent source of funding to all local governments to help cities and counties implement plans to increase affordable housing stock



PLHA Funding Will Help Cities and Counties:

- Increase the supply of housing for households at or below 60% of area median income
- Increase assistance to affordable owner-occupied workforce housing
- Assist persons experiencing or at risk of homelessness
- Facilitate housing affordability, particularly for lower- and moderateincome households
- Promote projects and programs to meet the local government's unmet share of Regional Housing Needs Allocation
- Ensure geographic equity in the distribution of the funds



Collaboration:

- Under PLHA, Small cities can "delegate" their share of allocated PLHA funds to a larger jurisdiction
- In June, Grass Valley and Nevada City opted to do delegate to the County their allocations of PLHA funding
- Both Cities and the County have been working closely together to review eligible activities



The Plan:

- \$2.6 Million in PLHA funding over 5 years
- 80% of funding to increase housing stock
- 20% to Sheltering operations
- Utilize PLHA funds to form a Western Nevada County Regional Housing Trust Fund
- Leverage <u>Local</u> commitment of PLHA Housing Trust Funds to seek <u>State</u> matching dollars through the Low Income Housing Trust Fund Grant Program
- Provide assistance to general shelter operations: expand seasonal shelters and sustain low barrier access Countywide
 Better Together

NEVADA COUNTY

The Impact:

- Fosters collaboration between County and Cities towards the coordinated development of affordable housing
- Establishes an ongoing source of funding to provide affordable housing project developers with low and deferred interest loans
- Leverages locally committed PLHA funds to seek state matching funds, doubling the local investment over 5 years.
- Provides a source of funding to assist in shelter operations while we build housing




Authorization of LHTF:

- Partnership Makes Application Possible
- Guidelines:
 - Use Funds for Construction Loans or Permanent Financing
 - Bulk of Funds Must be Spent on Lower Income Households (80% AMI maximum)
 - \$750K Minimum Commitment to Apply (yearly if funds are available)
 - Maximum Match up to \$5M Per Year.
- Encourages Investment of Local Funds into Community Housing Projects by matching them with State funds
