Dear Supervisor Heidi,

I received a call from Alison Lehman early last week asking about the financial situation with the Miners Foundry Cultural Center. I understand the County of Nevada is going to be discussing the funding received from the CARES Act and we really need your support to advocate for us.

When we began the stay-at-home order on March 19th, we had a nice cushion saved. We felt it was not necessary to sound the alarm bells at that time and believed strongly that our community needed to gather its own bearings before we reached out to ask for help.

Although the Miners Foundry building was closed to the public beginning March 12th, staff has been diligently working behind the scenes. We immediately began researching and applying for every possible grant or loan that would help sustain our 161 year old building and continue our mission of serving Nevada County. We also laid off all non-essential personnel and cancelled all nonessential services. At the end of March, we immediately applied for and received the PPP funds and applied for and are still waiting to receive the EIDL funds.

Because we are a community gathering space and event venue, we are not able to function as such and have lost all our traditional sources of revenue. Since March we have lost over \$200,000 in revenue. We are currently running at a 50K deficit each month and at this point predict we will be out of cash by September. If this happens, the Miners Foundry Cultural Center will need to close our doors.

As the majority of our events are classified within Stage 4, it quickly became apparent "business as usual" would not be returning to the Miners Foundry any time soon. Drawing inspiration from our mission and the long history of the building, we decided to pivot and launch a new business allowing us to continue to serve our community and for our community to be able to enjoy the beloved Foundry.

Our goal is to continue to fulfill our mission of serving our community and providing a gathering space for historical, educational, cultural, and social activities in Nevada County. No one wants to see the Foundry turned into a retail space with multiple shops, a sake factory, or even demolished. Historic buildings as unique and beautiful as the Miners Foundry carry the cherished memories of each generation forward. To lose such a monumental shared community experience would be devastating to Nevada City and Nevada County. With a type 47 liquor license (restaurant and bar), a commercial kitchen, and an extremely large and flexible space, we decided to open a bar and cafe, and when allowed, a gathering place for smaller numbers. We plan to offer Sunday brunches in the near future and continue to brainstorm new and creative ways the space can be enjoyed by our community in a safe and healthy environment. The Miners Foundry is essentially starting a new business and we are very undercapitalized. We cannot borrow our way out of this situation. We need support as we move through these stages.





Once (if) we get to Stage 4, the plan is to shift back to providing a space for the community to gather in larger numbers. The staff and board at the Foundry are very adept and skilled at shifting and we are used to being flexible, so these changes will not be as much of a challenge for us as they might for others. We are also extremely fortunate to be the caregivers of a large, flexible space. The Miners Foundry has demonstrated repeatedly over the last 161 years it has the ability to pivot and support the needs of our community.

The Foundry is an essential and integral part of the community and closing our doors is not an option the City and County can afford. I have attached a 2018 Economic Impact report of the Foundry. This is using the multipliers determined by the Americans for the Arts. We consider these numbers to be much higher because weddings generate far more revenue for a community than the arts per dollar spent. Multiple sectors of our community benefit tremendously from the continued operation of the Foundry including restaurants, hotels, shops, family businesses, performing and visual artists, vendors and those who are self-employed.

We have been here for the community for nearly every disaster or cause as well as in times of celebration. Whenever there is an emergency need in the community, the Foundry is there, willing and able to provide the space for all of us to gather together in support of a cause and each other. It's time for the City of Nevada City, County of Nevada and our beloved Community to come together in support of this historic venue that holds the hearts of so many people in the community. We hope we will receive the same enthusiastic support from the County that we have so wholeheartedly given over the decades.

I encourage you and the other members of the Board of Supervisors to vote in favor of providing the Miners Foundry Cultural Center with the necessary CARES Act funding to keep us intact during these times.

I am writing to request support from the Board of Supervisors in support of Cares Act Funding for arts and culture anchor institutions in our community. I have served as Vice President of the Board for The Center for the Arts for the last six years and would like to share with you some of the benefits we have brought to Nevada County.

What CFTA has Done

For over 20 years the Center has provided our county with a venue that has brought artists covering a broad range of musical & theatrical shows to the county. Over time we have been able to attract nationally known artists into our community. The compliment we receive from arts is typically that they love our community, the patrons really appreciate their music & they'd be happy to come back. Beyond the impact to county residents, we attract audiences from outside our county who regularly patronize local restaurants and hotels.

Beyond musical & theatrical performances we also The Center also does the following:

- Open Studios Tour which highlights the work of the counties' many artists.
- Summer education classes for children exposing them to The Arts

Center Renovation

To be competitive with other venues in Northern California and provide a better experience for our patrons we embarked on a campaign to raise plans to renovate our theater. This has resulted in a 500 seat theater with the best sound system outside of the Bay Area that will attract even more patrons to our county. It was interesting to note that during the construction period we received comments from local restaurants and bars that they had noticed a dropoff in their business because of the lack of shows being put on by The Center.

Our renovation effort was recently completed and opened for its first show just before the Covid crisis forced a shutdown.

Center Adapting to Current Situation

The Center has adapted to our current situation. With the lack of shows that have traditionally provided 60% of our revenue, we raised funds from donors to support our activities.

We are currently offering Summer Arts Education courses for children & have adapted these programs to operate with the safety guidelines the county & other authorities provided. We think it is extremely important to provide these opportunities for children to experience the Arts as part of their educational opportunities.

With additional funding through the Cares Acts Funding program we can extend these types of programs into the future to augment Children's education. We are looking to offer education programs that can be scheduled to be compatible with upcoming Fall School schedules. This also provides a needed break from parents in caring for their children while enhancing their education. I urge your support for The Center for the Arts using Cares Act Funding – it will be a great investment for our community.
