I was a NAMI Nevada County "Anxiety & Depression" support group facilitator - weekly for ten years. Subsequent to that, I facilitated the "Anxiety & Depression" support group at the SPIRIT Peer Empowerment Center from April 2015 until late February 2020 and then withdrew due to the COVID-19 exposure potential.
