BACKGROUND:

As required by the California Penal Code, Section 933 (b), the Board of Supervisors must submit comments to the presiding judge of the Superior Court on the findings and recommendations included in the Civil Grand Jury Report pertaining to matters under the control of the Board.

For each Grand Jury finding, the Board must indicate either:

- 1. Agreement with the finding
- 2. Disagreement either wholly or partially with the finding.

Responses to Grand Jury recommendations must indicate one of the following actions:

- 1. The recommendation has been implemented.
- 2. The recommendation has not yet been implemented, but will be by a certain date.
- 3. The recommendation requires further analysis to be completed within six months.
- 4. The recommendation will not be implemented for reasons as explained.

Staff has prepared draft responses to each of the findings and recommendations requiring a response for the Board's consideration. The responses to findings and recommendations are based on examination of official county records, review of the responses by the County Executive Officer, County Counsel and representatives or testimony of the Board of Supervisors and County staff. The responses also represent the Nevada County Purchasing Agent response as requested by the Grand Jury.
