WHEREAS, whenever two or more elections are called to be held on the same day, in the same territory, or in part of the same territory, such elections should be consolidated;

NOW, THEREFORE, BE IT RESOLVED that an election be held on November 3, 2020 for the purpose of electing **two** members to the District Board of Directors; and

BE IT FURTHER RESOLVED THAT the **Grass Valley School District** requests the governing body of the County of Nevada, as prescribed by Elections Code Section 10402 and 10403 to consolidate the regularly scheduled district election with any other elections to be held on November 3, 2020, and

BE IT FURTHER RESOLVED THAT the **Candidate** is to pay for the publication of the candidate's statement, pursuant to Elections Code Section 10509. The limitation on the number of words that a candidate may use in his/her Candidate's Statement is **200** words; and

BE IT FURTHER RESOLVED THAT the **Grass Valley School District** agrees to reimburse the County of Nevada for the district's prorated share of the costs of the election.
