In the <u>case of a tie vote</u>, the election shall be determined by lot. (Election Code section 5016, E.C. section 5016 & 5034)

4. The County Clerk is requested to provide election services. (E.C. section 23523 & 23524)

This Resolution shall be considered a Notice of Election and Specification of Election Order, pursuant to Education Code Section 5322.
