SUBJECT: Resolution approving execution of Amendment No. 02 to the

Personal Services Contract with Sierra Nevada Children's Services (SNCS) for services related to administration of the Emergency Child Care Bridge Program for Foster Children (Bridge Program) to 1) increase the maximum amount to \$176,407 (an increase of \$1,795) for the term of July 1, 2019 through June 30, 2021; and 2) revise Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum

contract price. (RES. 19-504) (RES. 19-565)

RECOMMENDATION: Approve the attached Resolution.

<u>FUNDING</u>: Contract services are funded through State general funds from the California Department of Social Services Emergency Child Care Bridge Program for Foster Children (Bridge Program) allocation and 1991 Realignment. A budget amendment is not necessary and there are no county general funds required in the Agreement.

BACKGROUND: The goal of the Bridge Program is to increase the number of foster children successfully placed in home-based family care settings. One of the primary barriers for potential families seeking to take in a foster child is the lack of access to child care immediately following the removal of the child. With the passage of SB 89, resource families that have a child placed with them in an emergency or for a compelling reason are eligible to receive a time-limited monthly payment or vouchers for child care and a child care navigator. Child care programs and providers serving children in the Bridge Program shall be provided with trauma-informed care training and coaching.

Sierra Nevada Children's Services, a private, nonprofit child care resource and referral agency that has served families, early childhood professionals, and the Nevada County community since 1978, will provide services related to the administration of the Bridge Program pursuant to this Agreement.

The California Department of Social Services is providing additional allocations of funding to assist counties to expand the Bridge Program and extend the time that benefits are available. These funds will support all three of the components of the Bridge Program to enable families to receive a voucher to help with child care, a child care navigator to help families find child care, and provide trauma-informed care training and coaching to child care providers.

It is recommended that the Board approve this Amendment as the services the Contractor will be providing will help decrease the barriers for placement of foster children.
