**RESOLUTION CONSOLIDATING THE CITY OF GRASS VALLEY TAX MEASURE, CITY OF NEVADA CITY TAX MEASURE, TOWN OF TRUCKEE TAX MEASURE, BYERS LANE COMMUNITY SERVICE DISTRICT TAX MEASURE, CITY OF NEVADA CITY MEASURE PERTAINING TO ELECTIVE OFFICES, THE CITY OF GRASS VALLEY AND TOWN OF TRUCKEE GENERAL MUNICIPAL ELECTIONS, CITY OF NEVADA CITY SPECIAL MUNICIPAL ELECTION, SCHOOL DISTRICTS BOARD OF DIRECTORS GENERAL DISTRICT ELECTIONS, SPECIAL DISTRICTS GOVERNING BOARD OF DIRECTORS GENERAL DISTRICT ELECTIONS WITH THE GENERAL ELECTION TO BE HELD IN THE COUNTY OF NEVADA IN THE STATE OF CALIFORNIA ON TUESDAY, NOVEMBER 3, 2020**

WHEREAS, The City of Grass Valley has called for the submission of a tax measure to the voters, and hereby requests said tax measure be consolidated with the General Election to be held in the County of Nevada on November 3, 2020, authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary for the conduct of the election for each voter registered on the 15th day prior to Election Day in each section of the County for which there appears on the ballot measure for that city or district; and

WHEREAS, The City of Nevada City has called for the submission of a tax measure to the voters, and hereby requests said tax measure be consolidated with the General Election to be held in the County of Nevada on November 3, 2020, authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary for the conduct of the election for each voter registered on the 15th day prior to Election Day in each section of the County for which there appears on the ballot measure for that city or district; and

WHEREAS, The Town of Truckee has called for the submission of a tax measure to the voters, and hereby requests said tax measure be consolidated with the General Election to be held in the County of Nevada on November 3, 2020, authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary for the conduct of the election for each voter registered on the 15th day prior to Election Day in each section of the County for which there appears on the ballot measure for that city or district; and

WHEREAS, The Byers Lane Community Service District has called for the submission of a tax measure to the voters, and hereby requests said tax measure be consolidated with the General Election to be held in the County of Nevada on November 3, 2020, authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary for the conduct of the election for each voter registered on the 15th day prior to Election Day in each section of the County for which there appears on the ballot measure for that city or district; and

WHEREAS, The City of Nevada City has called for the submission of a measure pertaining to elective offices to the voters, and hereby requests said elective offices measure be consolidated with the General Election to be held in the County of Nevada on November 3, 2020, authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary for the conduct of the election for each voter registered on the 15th day prior to Election Day in each section of the County for which there appears on the ballot measure for that city or district; and

WHEREAS, The City of Grass Valley hereby requests a General Municipal Election be consolidated with the General Election to be held in the County of Nevada on November 3, 2020; authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary for the conduct of the elections, and states that the district will reimburse the County for their prorated share of the cost of the election for each voter registered on the 15th day prior to Election Day; and

WHEREAS, The Town of Truckee hereby requests a General Municipal Election be consolidated with the General Election to be held in the County of Nevada on November 3, 2020; authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary for the conduct of the elections, and states that the district will reimburse the County for their prorated share of the cost of the election for each voter registered on the 15th day prior to Election Day; and

WHEREAS, The City of Nevada City hereby requests a Special Municipal Election be consolidated with the General Election to be held in the County of Nevada on November 3, 2020; authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary for the conduct of the elections, and states that the district will reimburse the County for their prorated share of the cost of the election for each voter registered on the 15th day prior to Election Day; and

WHEREAS, The following school districts hereby request that their General Elections be consolidated with the General Election to be held in the County of Nevada on November 3, 2020: Chicago Park School District, Clear Creek Elementary School District, Grass Valley School District, Nevada City School District, Nevada County Board of Education, Nevada Joint Union High School District, Penn Valley Union Elementary School District, Placer County Board of Education, Pleasant Ridge Union School District, Sierra Joint Community College District, Tahoe Truckee Unified School District, Twin Ridges Elementary School District, and Union Hill School District; authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary for the conduct of the elections, and states that the district will reimburse the County for their prorated share of the cost of the election for each voter registered on the 15th day prior to election; and

WHEREAS, The following special districts hereby request that their General Elections be consolidated with the General Election to be held in the County of Nevada on November 3, 2020: Higgins Area Fire Protection District, Nevada County Consolidated Fire District, North San Juan Fire Protection District, Ophir Hill Fire Protection District, Peardale-Chicago Park Fire Protection District, Penn Valley Fire Protection District, Rough and Ready Fire Protection District, Truckee Fire Protection District, Bear River Recreation and Park District, Oak Tree Community Park and Recreation District, Beyers Lane Community Service District, Donner Summit Public Utility District, Lake of the Pines Ranchos Community Service District, Mystic Mine Road Community Service District, Nevada Irrigation District, San Juan Ridge County Water District, Washington County Water District, Western Gateway Recreation & Park District, Tahoe Forest Hospital District, Truckee Donner Public Utility District, Truckee-Donner Recreation and Park District, Truckee Sanitary District and Truckee-Tahoe Airport District; authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary for the conduct of the elections, and states that the district will reimburse the County for their prorated share of the cost of the election for each voter registered on the 15th day prior to election; and

WHEREAS, Elections Code §§ 10400, 10401, 10402 and 10403 provide that the County Board of Supervisors may order the consolidation of any election called for the submission of a question, proposition, or office.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that: the City of Grass Valley Tax Measure, Town of Truckee Tax Measure, Byers Lane Community Service District Tax Measure, City of Nevada City Elective Offices Measure, The City of Grass Valley and Town of Truckee General Municipal Elections, City of Nevada City Special Election; and the School Board and Special District General District Elections enumerated above shall be consolidated with the General Election to be held in the County of Nevada on Tuesday, November 3, 2020.

BE IT FURTHER RESOLVED, that the Nevada County Clerk-Recorder/Registrar of Voters shall be and is hereby authorized and directed to render all services necessary for the conduct of said elections.
