ACTION TAKEN: Ms. Phebe Bell, Behavioral Health Director, provided comments regarding the Mental Health and Substance Use Advisory Board. Ms. Amanda Wilcox, Mental Health and Substance Use Advisory Board President, reviewed the composition and the role of the Advisory Board. Ms. Wilcox reported on the core functions and key highlights for 2020 including; transition to a new president, increased diversity of outside presenters, input on department budget priorities, and approval of the Mental Health Services Act Three Year Plan, and integrated substance use disorder services oversight into the Advisorv Board's responsibilities. Ms. Wilcox reviewed successes of the Behavioral Health Department including; better integration of children's behavioral health and child welfare, increases in substance use and disorder services, success in attracting grant funding, and the addition of housing resources. She reviewed what issues they expect in the future including impacts of COVID-19 on behavioral health needs, fiscal concerns, the ongoing and potentially growing challenges of homelessness, the growing demand for Substance Use Disorder services, and the need for new Advisory Board members to fill the four vacancies currently on the Advisory Board. She thanked the Board of Supervisors and County staff who provide support for the Advisory Board.

Board questioning and discussion ensued.

SUMMARY MINUTES - Draft

Ms. Mali Dyck, Assistant County Executive Officer, provided the Board of Supervisors' responses to the Grand Jury report titled "CalFresh in Nevada County: Leaving Food (and Money) on the table". Ms. Dyck reviewed highlights of the report which included the need to increase CalFresh enrollment, the need to increase and improve the use of technology, and the need to improve case management strategies and efficiencies. Ms. Dyck reviewed the programs that have been put in place currently that have improved the County's CalFresh services and she reviewed the recommendations and next steps listed in the report including; increased use of direct outreach, new technology and partnerships, and continued process improvement in the Team approach.

Mr. David Anderson, Chair of the Grand Jury, provided comments that the Grand Jury has seen improvement in the CalFresh program since their report was issued.

Board questioning and discussion ensued.

ACTION TAKEN: Following a short break, Chair Hall called the meeting back into order and opened the public hearing regarding the General Plan Amendments to the 2020 Penn Valley Area Plan.

Mr. Brian Foss, Planning Director, and Mr. Tyler Barrington, Principal Planner, provided a presentation covering the recommended amendments including; changes to the General Plan Text, rezone of the General Plan Land Use Map with regard to the Western Gateway Park property, Zoning Map changes to the Site Performance Combining District and updates to the current Zoning Ordinance. Mr. Barrington reviewed the inclusion of community involvement in these changes and clarified that the plan is not a Capital Improvement Plan but a plan that helps guide future development.

Mr. Barrington reviewed the Plan's guiding principles including; development of a year-round economy that will foster local business, preserve community character, protect and restore natural resources, value historic resources, create community gathering places, and more. He reported on the Area Plan Boundaries and the creation of Individual Community Design Districts to help make appropriate decisions for specific areas such as the Village Core. He reviewed the goals and policies being proposed for Western Gateway Park including; supporting the Park's mission, encouraging path and trail systems to connect to the park, and encouraging special events. Mr. Barrington presented sites that have been identified as suitable for business and growth opportunities and the possibility of a non-motorized "Rural Corridor" that would extend from Lake Wildwood to the Village Core.

Mr. Barrington reviewed the Land Use Chapter, Economic Development, Public Service and Infrastructure, and the Historic, Cultural and Natural Resources Goals and Policies that emerged from the community involvement and that have been included in the updates to the Penn Valley Area Plan. He reported on the two years that the Plan has been in review and listed the individuals and County staff that participated in the Plan's review.

Supervisor Hoek spoke to the time and effort County staff devoted to the process and the number of Penn Valley residents that participated. She felt that the process has been thorough and complete, and she thanked staff for their hard work.

Board questioning and discussion ensued.

The following members of the public provided comment: Ms. Teresa, District IV resident; Mr. Ray Favetti, District IV resident; and Mr. Mike Mastrodonato, District IV resident, and Chair of the Penn Valley Municipal Advisory Council.

Mr. Barrington responded to public comment regarding additional traffic and crisis evacuation concerns and stated that there are no development proposals associated with this Area Plan that would result in additional traffic. He stated that one of the goals of the plan was to maintain the rural quality of life.

There being no further public comment, Chair Hall closed the public comment period.

Following closed session, Ms. Katharine Elliot, County Counsel, reported out that the closed session was informational only and no action was taken.

26. <u>SR 20-3378</u> Acceptance of the Wildfire Preparedness Informational Presentation to the Board by Office of Emergency Services and Stakeholders. (Emergency Services)
 Accepted.

ACTION TAKEN: Chief Brian Estes, Nevada, Yuba, Placer Unit of CALFIRE, reviewed the dry lightening conditions that happened recently that resulted in so many fires, including the Jones Fire. He provided information on the Jones Fire including that it destroyed 14 homes and 1 business, plus it also damaged additional residences and various other structures. Chief Estes added that they were able to directly save 20 homes. He reported on the resources used to fight the fire and of the unified efforts between CALFIRE, the County, the Sheriff's office, Nevada County Consolidated Fire District, and the California State Parks.

Nevada County Sheriff Shannon Moon reported on the unified command center and the Nevada County Sheriff's Office response which included; issuing evacuation orders and warnings, conducting evacuations, conducting animal evacuations to the Nevada County Fairgrounds, Law Enforcement Mutual Aid Response, and the Sheriff's work in partnership with the Office of Emergency Services. She provided information regarding the new Hi-Lo Sirens, Evacuation Tags, CodeRED Emergency Alerts, and the Ready Nevada County Dashboard that all helped with quick communication throughout the community. Sheriff Moon thanked Chief's Estes, Turner, and Mathias for their efforts, coordination, and response to Nevada County during the Jones Fire.

Board discussion ensued and the Board thanked all of the participants for their united and successful efforts to fight the Jones Fire.

Ms. Julie Patterson Hunter, Clerk of the Board, reported that no public comment was received for this item.

Mr. Paul Cummings, Program Manager, Office of Emergency Services, reported on the Office of Emergency Services' (OES) response to the Jones Fire including the cooling centers that were already set up for the high weather temperatures and were subsequently used as evacuation centers. He additionally reported on other fires that resulted from the lightening strikes in Nevada County. Mr. Cummings noted that the Emergency Operations Center was activated in response to the Jones Fire, and is now in recovery mode. He spoke to the services provided by the 211 community number, and reported on the emergency proclamation resulting from the Jones Fire that OES is requesting the Board pass today.

Mr. Cummings reviewed the Defensible Space Program timeline for processing inspections.

Mr. Brandon Sanders, Sierra Division, Public Affairs, Pacific Gas and Electric (PG&E), provided information with an overview of Nevada County and Public Safety Power Shutoff (PSPS) improvements, including their efforts to energize downtown Nevada City during a PSPS event.

Mr. Aaron Johnson, Vice President of PG&E's Community Wildfire and Safety Program, reviewed the input PG&E has received from the community and listed additional improvements they have made in order to make the PSPS events far less impactful on the community. He reported that PG&E's improvement goal is to make the PSPS events "Smaller (in size), Shorter (in length), and Smarter (for customers)." He reported on their plan to provide more assistance before, during and after the event, including support for customers with medical needs. In addition, he reported that PG&E has been in contact with Sierra Nevada Memorial Hospital to ensure continued operations during PSPS events. Mr. Johnson reviewed the challenges they

faced to be sure that Nevada City would be energized during a PSPS event.

Mr. Sanders reported on the installation of stronger and more resilient poles, cover power lines, the equipment that is being replaced and the targeted undergrounding being conducted where appropriate, also he reported on the enhanced vegetation work being done along segments of Brunswick to ensure safe operation to Nevada City during a power safety shutoff.

Board questioning ensued.
