
Administering Elections Under COVID-19

- 16 states postponed primaries
- Some states kept election dates and processes by court orders
- Little reference to past experience
- Hundreds of polling places forced to shut down
- Poll worker recruitment crisis



Contextual Factors Affecting Elections

- Politics of public health
- Politics of funding elections
- PSPS events and wildfire contingencies
- Civil unrest
- Elections cybersecurity concerns
- Mis-/disinformation
- USPS controversy
- Implications for national security





Solving for COVID-19 Collaboratively

- SOS/CACEO task force and recommendations to Governor and lawmakers
- Executive Orders 64 and 67, AB 860 and SB 423
 - All counties send all active registered voters a ballot
 - Registrar discretion to open vote centers 3 days
 before election
 - Accept completed ballots at E+17 if properly postmarked
 - Mandatory in person voting options
- County partnerships

Ballot Distribution and Return



Voter's Choice Act of 2016

- Nevada was one of five pilot counties to implement in 2018
- 7 elections-worth of experience
- Everyone gets a mailed ballot
- In person voting available

(1 vote center/10,000 registered voters)





Overview of Nevada County's Election System

- Vote in-person
- Drop off a ballot
- Get a replacement ballot
- Accessible voting machines
- Get help and voting material in multiple languages
- Register to vote or update voter registration
- 8 locations






Key Election Security Features

- Voter registration records updated regularly
- No part of the voting system is connected to the Internet (Ca. Elec. Code § 19205)
- Ballots sent only to active voters
- 2-person verification/chain of custody procedures
- All signatures verified
- Most drop boxes are inside and monitored

While voters remain confident that their own votes are being counted as intended, confidence in national results has declined.
