RESOLUTION APPROVING THE NOTICE OF ACCEPTANCE AND COMPLETION OF THE CONTRACT WITH EXTREME ROOFING FOR THE NEVADA COUNTY ROOF RESTORATION AND REPLACEMENT PROJECT AT VARIOUS LOCATIONS 2020 FOR COMPOSITE ROOF REPLACEMENT AT THE BOST HOUSE WITH CONTRACT COSTS TOTALING \$65,190 AND DIRECTING THE CLERK OF THE BOARD TO RECORD THIS NOTICE IN ACCORDANCE WITH CIVIL CODE SECTION 9208

WHEREAS, construction documents were prepared and approved through Resolution 20-119 for the project known as the Nevada County Roof Restoration and Replacement Project at Various Locations 2020; and

WHEREAS, the various locations include the Grass Valley Library, Bost House, Nevada City Courthouse, Madelyn Helling Library and the Truckee Government Center; and

WHEREAS, the County of Nevada entered into a Standard Public Works Contract with Extreme Roofing (16221 Rattlesnake Road, Grass Valley, California, 95945) through Resolution 20-340, totaling \$65,230 including a 10% contingency; and


WHEREAS, said Contract was for the Nevada County Roof Restoration and Replacement Project at Various Locations 2020 for Composite Roof Replacement at the Bost House in accordance with the plans and specifications; and

WHEREAS, said improvements were completed to the satisfaction of the Nevada County Building Department and the Chief Information Officer on September 9, 2020, with contract costs totaling \$65,190.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Accepts the work as being completed.
- 2. Directs the Clerk of the Board to release the Bond for Labor and Materials on December 9, 2020 and the Bond of Faithful Performance on November 1, 2021.
- 3. Directs the Clerk of the Nevada County Board of Supervisors to record this notice in accordance with Civil Code Section 9208.

BE IT FURTHER RESOLVED THAT the Auditor-Controller is hereby authorized and directed to release and pay the 5% retention thirty-five (35) days after of the recording of the Notice of Completion, or no later than sixty (60) days after completion of the project as defined in PCC Sec. 7107, whichever occurs first, to assure that there are no Stop Payment notices filed against the project.


