### **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

**RESOLUTION APPROVING EXECUTION OF THE WORK ORDER  
AGREEMENT WITH PUBLIC HEALTH FOUNDATION  
ENTERPRISES, INC. DBA HELUNA HEALTH TO PERFORM  
LOCAL HEALTH DEPARTMENT COVID-19 RESPONSE  
ACTIVITIES IN THE MAXIMUM AMOUNT OF \$187,664 FOR THE  
CONTRACT TERM OF MAY 1, 2020 THROUGH MARCH 31, 2022  
AND AUTHORIZE AND DIRECT THE AUDITOR-CONTROLLER  
TO AMEND THE PUBLIC HEALTH DEPARTMENT'S BUDGET  
FOR FISCAL YEAR 2020/21 (4/5 AFFIRMATIVE VOTE REQUIRED)**

WHEREAS, on April 23, 2020 the Centers for Disease Control and Prevention (CDC) awarded \$631 million from the Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020 to support state and local COVID-19 response efforts; and

WHEREAS, the California Department of Public Health has contracted with Public Health Foundation Enterprises, Inc. DBA Heluna Health to administer contracts to local public health departments for their allocation of this funding; and

WHEREAS, the California Department of Public Health is allocating \$187,664 to the County of Nevada Public Health Department to rapidly establish and monitor key activities related to COVID-19 in the areas of epidemiology, laboratory, and data collection and analysis; and

WHEREAS, the Nevada County Public Health Department will allocate this funding to the highest priority response needs in communicable disease control including case investigation and contact tracing, disease surveillance, supporting testing, coordination with and outbreak control and prevention for vulnerable populations.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Work Order Agreement with Public Health Foundation Enterprises, Inc. DBA Heluna Health, for the term of May 1, 2020 through March 31, 2022 in the maximum amount of \$187,664 be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Work Order Agreement on behalf of the County of Nevada.

BE IT FURTHER RESOLVED that the Auditor-Controller is authorized and directed to amend the Health and Human Services Agency Public Health Department's Budget for Fiscal Year 2020-21 as follows:
