

RESOLUTION NO. 20-495

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPOINTING MEMBERS TO THE SPECIAL DISTRICT BOARDS WITH INSUFFICIENT CANDIDATES

WHEREAS, on September 22, 2020, the Board of Supervisors adopted Resolution 20-412, appointing candidates who filed declarations of candidacy and faced no opposition to Special District Boards; and

WHEREAS, Elections Code Section 10515 provides that the Board of Supervisors may appoint any remaining vacancies; and

WHEREAS, the following districts with remaining vacancies were notified by the Clerk of the Board that the Board of Supervisors was seeking qualified applicants to fill the upcoming vacancies: Beyers Lane Community Service District, Higgins Area Fire Protection District, Lake of the Pines Ranchos Community Service District, Mystic Mine Road Community Service District, Oak Tree Park and Recreation District, San Juan Ridge County Water District and Washington County Water District; and

WHEREAS, a Public Notice of Insufficient Candidates was published in the Union Newspaper on October 8 and 15, 2020, and posted on county bulletin boards pursuant to Government Code 549784 and placed on the County website; and

WHEREAS, applications were not submitted for the upcoming positions on the Beyers Lane Community Service District; and

WHEREAS, applications were not submitted for the upcoming positions on the Lake of the Pines Ranchos Community Service District; and

WHEREAS, applications were not submitted for the upcoming positions on the Mystic Mine Road Community Service District; and

WHEREAS, applications were not submitted for the upcoming positions on the North San Juan Fire Protection District; and

WHEREAS, applications were not submitted for the upcoming positions on the Oak Tree Park and Recreation District; and

WHEREAS, one application from Richard Thickens was received for the upcoming position on the Higgins Area Fire Protection District; and

WHEREAS, two applications from incumbents Michael Covert and Michele Roush Rowe were received for the three upcoming positions on the San Juan Ridge County Water District; and

WHEREAS, two applications from incumbent Amy Boyle and new applicant Alyssa Wittler were received for two of the three upcoming positions on the Washington County Water District.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of Nevada County hereby appoints Richard Thickens to the Higgins Area Fire Protection District for a fouryear term ending December 6, 2024; and

BE IT FURTHER RESOLVED that the Board of Supervisors of Nevada County hereby appoints Michael Covert and Michele Roush Rowe to the San Juan Ridge County Water District for four-year terms ending December 6, 2024; and

BE IT FURTHER RESOLVED that the Board of Supervisors of Nevada County hereby appoints Amy Boyle and Alyssa Wittler to the Washington County Water District for four-year terms ending December 6, 2024.
